Ms. B. Van Dike presented the first reading of Resolution No. 2017-41 presented by the Finance Committee as follows:

RESOLUTION DECLARING THE NECESSITY OF AN ELECTION ON THE QUESTION OF APPROVING THE PASSAGE OF AN ORDINANCE TO AMEND SECTIONS 37.012 AND 37.013 OF THE CODE OF ORDINANCES OF THE VILLAGE OF MOGADORE IN ORDER TO REMOVE THE EXPIRATION DATE PERTAINING TO THE PERIOD OF TIME IN WHICH A PORTION OF THE INCOME TAX IS LEVIED AND COLLECTED.
