

Council met in regular session at 5:30 p.m. with Mayor Michael Rick presiding.

Mayor Rick asked everyone to join him in a moment of reflection for their own intentions due to the absence of Mr. M. Kelly. The Pledge of Allegiance to the Flag was recited by all.

Motion by Mr. M. Raddish, second by Mr. R. Schrock for the approval of the agenda as presented. Vote. Unanimous ayes. Motion carried.

Motion by Mr. M. Raddish, second by Ms. K. Miller to adopt the minutes of the February 15, 2017 Council meeting. Vote: Unanimous ayes. Motion carried.

COMMITTEE REPORTS

PARKS – Ms. Miller stated that there will be Park Board meeting on March 8 at 6:30 at the municipal building.

UTILITIES – Mr. Schrock updated the questions and problems with Republic Waste Recycling. He has found out that some employees of the Republic Waste Customer Service are not aware that Mogadore has a recycling program with the company and the published scheduled pick dates and the days the trucks come into town do not coordinate. Mr. Schrock and the mayor will continue to work with Republic Waste and to get the problems resolved.

SAFETY – There was no report due to Mr. Kelly's absence.

STREETS – Mr. Yoho had no report.

PLANNING AND ZONING – Mr. McDowall stated that there will be Zoning Board of Appeals meeting on March 21 at 7:00.

Mr. Raddish remarked that we have carried this note for quite a few years and since we have extra money why aren't we paying this note off and asked how many years to pay off this note. Mayor Rick answered that \$100,000 was being spend between the three notes and it would take about six (6) years to pay off.

A RESOLUTION STRONGLY OPPOSING THE STATE OF OHIO GOVERNOR'S PROPOSED 2017-2018 BUDGET, WHICH PROPOSES CENTRALIZED COLLECTION OF NET PROFIT TAX RETURNS AND OTHER PROVISIONS RELATED TO THE MUNICIPAL INCOME TAX WHICH WILL CAUSE A SUBSTANTIAL LOSS OF REVENUE NEEDED TO SUPPORT THE HEALTH, SAFETY, WELFARE AND ECONOMIC DEVELOPMENT EFFORTS OF OHIO MUNICIPALITIES, AND DECLARING AN EMERGENCY
