Mayor Rick thanked June Long and the cemetery board for their time and effort in updating the Cemetery Rules and Regulations.

COMMENTS ON THE BILLS - Ms. B. Van Dike made a motion to approve the payment of the bills as presented on the invoice report; Mr. C. Yoho seconded the motion. Vote. Unanimous ayes. Motion carried.

COMMENTS from the Public: June Long, 4061 Etter Rd; reporting for the cemetery board. Ms. Long thanked council for adopting the updated Cemetery Rules and Regulations. She stated that the adoption date should be April 28, that is the date the board voted.

COMMENTS from Council: Mr. M. Kelly asked about a 4-way stop at Hale and Curtis due to the cars speeding on Hale. There is a lot of traffic and pedestrians in the area due to the park and school and all of the activities. Mayor Rick stated that this issue was discussed a few years ago and does not think a 4-way stop could be put there due to state standards. Per discussion, Mayor Rick is going to ask Chief Higgins to put the speed trailer on Hale and that should slow traffic.

Ms. B. Van Dike, Mr. R. Schrock and Mr. J. Reed announced that they will not be able to attend the May 17, 2017 council meeting.
