COMMENTS from the Public: John Mencer, 242 S. Cleveland Ave; stated he was glad to see the Police Department hire a female officer. He thinks a female can interact with children and other citizens in certain situations better than a male officer.

COMMENTS from Council: Mr. M. Kelly asked what the status of the baseball fields. Mayor Rick said the Village would give the league one-half for the dirt and then there would be no more funding.

Mr. B. Schrock reported he received a complaint about trees on the corner of Martin and Randolph blocking driver's view turning onto Randolph. Mayor Rick told him the office would look into it.

Mr. B. Schrock also said that he heard that the deli is selling glass pipes.
