SPONSOR: SAFETY COMMITTEE

A RESOLUTION RETROACTIVELY AUTHORIZING THE MAYOR OF THE VILLAGE OF MOGADORE TO ENTER INTO AN AGREEMENT FOR THE COUNTY OF SUMMIT-AKRON REGIONAL RADIO SYSTEM AND DECLARING AN EMERGENCY

WHEREAS; the County of Summit and the City of Akron are offering a county-wide regional radio system which provides for public safety radio communications; and,

WHEREAS; the Village of Mogadore desires to contract the County of Summit and the City of Akron for equipment and maintenance of said system; and,

WHEREAS; the Village of Mogadore recognizes that this User Agreement will enable the Village of Mogadore to spend its resources in a manageable way and with certainty; and,

WHEREAS; this agreement will allow the Village of Mogadore to immediately preserve the public peace, health, safety, convenience and welfare of its taxpayers and the inhabitants thereof;

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

Section 1: That the Mayor of the Village of Mogadore is hereby retroactively authorized and directed to promptly enter into a contract with the County of Summit and the City of Akron regarding a county-wide Regional Radio System, in a form similar to the User Agreement attached hereto as Exhibit "A."

Section 2: That the Mayor and Clerk-Treasurer are hereby retroactively authorized and directed to sign all necessary paperwork to effectuate the entering of, execution and implementation of said agreement.

Section 3: That, to the extent not already done so, the funds required for the payment of the obligations incurred are hereby appropriated for the purposes described.

Section 4: That this Council hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council which resulted in formal action were taken in meetings open to the public, in full compliance with the applicable legal requirements including Section 121.22 of the Ohio Revised Code.
