SPONSOR: SAFETY COMMITTEE

A RESOLUTION AUTHORIZING THE MAYOR AND/OR POLICE CHIEF TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE CITY OF TALLMADGE REGARDING ITS K-9 PROGRAM AND TO AUTHORIZE PAYMENT REGARDING THE SAME, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Tallmadge is expanding its K-9 program and has expressed an interest in sharing services and costs with the Village of Mogadore; and,

WHEREAS, it would benefit the health, safety and welfare of the residents of the Village of Mogadore to have additional protection of K-9 service and security.

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio that:

Section 1: That the Mayor and/or Police Chief is hereby authorized and directed to enter into a Memorandum of Understanding with the City of Tallmadge regarding the city's provision of K-9 protection and services to the Village of Mogadore and execute on behalf of the Village in a form substantially similar to the one attached as Exhibit "A" hereto.

Section 2: The Mayor and/or Police Chief is authorized for the expenditure of up to \$9,400.00 from the Village's K-9 program, including the funds donated by Omnova, for the provision of services under the subject Memorandum of Understanding. Further, the Village is authorizing donation of an Ace K9, CH-5020 Hot-n-Pop safety device to the Tallmadge K9 Program.

Section 3: That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

Section 4: That, to the extent not already done so, the funds required for the payment of the obligations incurred are hereby appropriated for the purposes described.

Section 5: All formal actions of this Council related to this Resolution and all deliberations of the Council and of any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
