A RESOLUTION APPROVING AND AUTHORIZING THE VILLAGE OF MOGADORE TO PARTNER WITH SUMMIT COUNTY AND/OR THE CITY OF AKRON, PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION STATE CAPITAL IMPROVEMENT PROGRAM(S) AND TO EXECUTE CONTRACTS AS REQUIRED, AND DECLARING AN EMERGENCY.

WHEREAS, the Ohio Public Works Commission has funding available for public works improvements; and,

WHEREAS, the Village of Mogadore, as part of the application process for these funds, has identified the need for the Infrastructure Project, Sunrise Boulevard West & Sunrise Boulevard South 2020; and,

WHEREAS, the Village of Mogadore has committed to fund its local share of costs associated with the improvement; and,

<u>SECTION 1</u>: That the Mayor, Clerk-Treasurer and, Village Engineer are authorized to act as a partner in a joint project with the County of Summit and/or the City of Akron to seek funding approval form the Ohio Public Works Commission for the Infrastructure Project, Sunrise Boulevard West & Sunrise Boulevard South 2020 Reconstruction.

<u>SECTION 2</u>: The Village of Mogadore will commit to provide its share of the local funding through general notes and bonds to construct the sewer improvement.

SECTION 3: The Mayor and/or Village Engineer are hereby authorized to apply to the OPWC for funds as described above.
