Mr. R. Schrock asked how this policy pertains to the Street Department with their CDL licenses. Mr. Pitchford said that the safety forces and street department are not permitted to partake in medical marijuana per this policy.

Mayor Rick said ordinance pertains to the wording of vacations for any new hires after January 1, 2019. Instead of new hires vacations starting on January 1, their vacations will start on their anniversary date. This change will not be a problem for the Clerk-Treasurer or payroll accountant.

Mr. M. Kelly made a motion to correct the resolution to read Kimberley Davis and Thomas N. Small. Ms. B. Van Dike seconded the motion. Vote. Unanimous ayes. Motion carried.

Ms. B. Van Dike presented Ordinance 2019-22 sponsored by the Finance Committee as follows:

AN ORDINANCE AMENDING THE ANNUAL APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITUES OF THE VILLAGE FOR THE FISCAL YEAR ENDING DECEMBER 31, 2019 AND DECLARING AN EMERGENCY

Ms. B. Van Dike made a motion to suspend the rule requiring three readings; Mr. R. Schrock seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Ms. B. Van Dike to adopt Ordinance 2019-22; a second was made by Mr. R. McDowall. Vote. Unanimous ayes. Motion carried.

Ms. B. Van Dike presented Resolution 2019-23 sponsored by the Finance Committee as follows:

ESTABLISHING CREDIT CARD POLICIES AND DECLARING AN EMERGENCY

Ms. B. Van Dike made a motion to suspend the rule requiring three readings; Ms. K. Miller seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Ms. B. Van Dike to adopt Resolution 2019-23; a second was made by Ms. K. Miller.

Mr. Varney stated that the village does not have a credit card policy but due to new State policies we must have one. Also, a yearly reconciliation has to be completed and a report to council.

Mr. Schrock asked if there is a \$2,000 limit on the cards as stated in the policy. The amount is correct.

Mayor Rick said card usage is minimal.

Vote. Unanimous ayes. Motion carried.

<u>COMMENTS ON THE BILLS</u> - Ms. B. Van Dike made a motion to approve the payment of the bills as presented on the invoice report; Mr. R. Schrock seconded the motion. Vote. Unanimous ayes. Motion carried.

COMMENTS from the Public: Jon Mencer, 242 S. Cleveland Ave; saw a Mogadore police officer in a Mogadore cruiser in Springfield Township working road duty. He asked if the village was being compensated. Mayor Rick was not aware of cruisers being used outside of Mogadore jurisdiction and would follow up with Chief Higgins.

COMMENTS from Council: Mr. M. Kelly asked what the Village can do about a Williams Ave. resident feeding stray cats and raccoons. This is creating a problem for the neighbors. Mayor Rick said that we have had this same problem in the past and we are not able to do anything but we will check with Summit County Health. He also stated that we cannot due anything to trap the cats.

Mr. Kelly asked if the village can notify the homeowner of this nuisance and how it is affecting neighbors. He suggested sending a letter. The mayor said the problem with sending a letter there will be no penalty that we can access.

Mr. Kelly said that he has set up a Facebook page with information for the income tax levy and urged everyone to check it out. He thanked Mr. Varney for providing the information. Mayor Rick stated one piece of information stated that 82% of the expenditures is for the Police, Fire and Streets departments and this is good for the residents to know.

Mr. Kelly also stated that local state representatives are working to get more funding for local governments and urged others to contact their offices in regards to this issue.

Mr. R. Schrock stated that a few weeks ago he mentioned that a resident asked for a wall clock at the community center. The resident complained that there still is not a clock. Mr. M. Kelly said he heard the same complaint. Mayor Rick said that we are looking into getting one.

Mr. Schrock also said a resident told him about a leaking fire hydrant on Second Ave. and there is a lot of ice build-up. Mayor Rick said he would ask Chief Cain to look into it.

Mr. M. Raddish thanked Mr. Kelly on his work for the income tax levy.

COMMENTS from the Clerk-Treasurer: - No comments.

COMMENTS from the Law Director: Mr. Pitchford said that he has been in contact with Suffield Twp trustees regarding the annexation of $3\frac{1}{2}$ lots to the West Village development. The township has voted to approve the annexation and an agreement will be forthcoming.

He also passed out a proposal from his office, Dicaudo, Pitchford & Yoder, regarding EMS collections when the Village signs the new agreement with Ohio Billing, Inc. He asked council to review and if choose their services, an agreement will be made. He also stated that with this agreement there will be no conflict of interest.

COMMENTS from the Mayor: - No comments.
