COMMENTS from the Public: June Long, 4061 Etter Rd; Ms. Long wished good luck to the wrestlers at the state tournament and the basketball team in the district finals.

John Yeargin, 261 Ridge Rd; questioned the mutual aid canine agreement with Tallmadge. He thought we had our own canine program. Mayor Rick stated that we did a couple of years ago and unfortunately the program did not work out.

COMMENTS from the Clerk-Treasurer - No comments.

COMMENTS from the Mayor: - Mayor Rick remarked about the gasoline sales tax that is up for vote in the Ohio House. He said that if the governor gets the \$.18 per gallon increase that he wants, the village could get an additional \$100,000 per year. The house is asking for \$.10 per gallon and we would receive about \$50,000 yearly.
