COMMITTEE REPORTS

PARKS – Ms. Miller had no report. Mayor Rick gave an update on the purchase of the Gator for the park. He has heard that the school is interested in contributing to the purchase of the Gator. After further research, looking at Gator with a rollbar and other features so there will be an increase in price. The features would insure safety and longevity.

Mr. Yoho asked what would the school need the Gator for? Mayor Rick said that he just heard about this idea. He heard that the school might need use the park for softball next year. He also stated that he would tell the school that the Gator does not leave park property.

COMMENTS from the Village Engineer: Mr. Glass gave an update on the AMATS application for Gilchrist Road. He thanked Mayor Rick. With the Mayor's involvement, the City of Akron has agreed to partner along with Summit County. Akron will pay 100% from Mogadore's border to Skelton, 50% for the rest of the project.


On July 3, Mr. Glass will deliver the OWPC application for the Sunrise East and South project.

Mr. Glass gave an update on the Prospect Reconstruction bid opening. Four of the bids received came in around \$1,000,000 which was the engineer's estimate. Cementech;s bid was around \$768,000. Mr. Glass asked council to award Cementech the contract at the next council meeting.

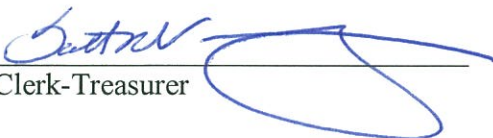
Mr. Glass will be on vacation the week of July 8.
