A RESOLUTION AUTHORIZING THE MAYOR AND FISCAL OFFICER TO ENTER INTO AN AGREEMENT WITH AND PAY AMERICAN LEGAL PUBLISHING FOR PREPARATION OF UPDATES AND ONLINE SERVICE FOR VILLAGE CODIFIED ORDINANCE, AND DECLARING AN EMERGENCY

WHEREAS, the Village updated its Planning and Zoning Code during 2018 and prepared other revisions for the Village's Codified Ordinances; and,

WHEREAS, American Legal Publishing has provided an estimate for updating the Village's Codified Ordinance books and provision of online services and display of the Village's complete Codified Ordinances.

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Summit, Portage and State of Ohio:

<u>SECTION 1</u>: That the Mayor and the Fiscal Officer are authorized and directed to enter into an agreement with American Legal Publishing for the updating of the Village's Codified Ordinances both in hard copy and online versions in an amount not to exceed \$20,000.00.

SECTION 2: That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

SECTION 3: That, to the extent not already done so, the funds required for the payment of the obligations incurred are hereby appropriated for the purposes described.

<u>SECTION 4</u>: All formal actions of this Council related to this Resolution and all deliberations of the Council and of any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5: This Resolution is declared to be an emergency measure necessary for the preservation of the public peace, health, safety, convenience, and welfare of the Village of Mogadore and the inhabitants thereof, and for the further reason that this Resolution must be immediately effective in order to provide for the services provided for herein, which are necessary to preserve and protect the interests of the Village. This Resolution shall be in full force and effect immediately upon its passage and approval by the Mayor.
