## RECORD OF ORDINANCES

Ordinance No. <u>2019-71</u> Passed <u>August 7</u> , 20 19

SPONSOR: FINANCE COMMITTEE

AN ORDINANCE TO LEVY A MUNICIPAL MOTOR VEHICLE LICENSE FEE PURSUANT TO SECTION 4504.173 OF THE OHIO REVISED CODE.

WHEREAS, pursuant to the Constitution of the State of Ohio and the Revised Code, municipal corporations have the power to adopt legislation deemed necessary and proper to protect the health, safety, welfare, comfort, and peace of the citizens of the municipality; and,

WHEREAS, this Council finds that an annual license tax upon the operation of a motor vehicle on public roads and highways is necessary and proper to protect the health, safety, welfare, comfort, and peace of the citizens of the Village.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Mogadore, Counties of Portage and Summit, Ohio, as follows:

SECTION 1: That there is hereby levied an annual license tax upon the operation of motor vehicles on the public roads or highways pursuant to Ohio Revised Code 4504.173, for the purposes of paying the cost and expenses of enforcing and administering the tax provided for this section; and to provide additional revenue for the purposes set forth in R.C. 4504.173(A)(2), and to supplement revenue already available for such purposes.

SECTION 2: Such tax shall be at the rate of five dollars (\$5.00) per motor vehicle on each and every motor vehicle, the district of registration of which as defined in Ohio Revised Code, Section 4503.10, is in the Village of Mogadore, Ohio. As used in this Ordinance, the term "motor vehicle" shall mean any and all vehicles included within the definition of motor vehicle in Sections 4501.01 and 4505.01 of the Ohio Revised Code.

SECTION 3: The tax imposed by this Ordinance shall apply to and be in effect for registrations commencing January 1, 2021 and shall continue in full force and effect and application during each registration year thereafter.

<u>SECTION 4:</u> The tax imposed by this Ordinances shall be paid to the Registrar of Motor Vehicles of the state of Ohio or to a deputy Registrar at the time application for registration on a motor vehicle is made as provided in R.C. 4503.10.

SECTION 5: This rate of tax is in addition to the tax rates prescribed in any other section of the Revised Code and adopted by the Village of Mogadore, relating to license tax for operation of motor vehicles.

SECTION 6: All monies derived from and as a result of the tax hereinbefore levied shall be used by the Village of Mogadore for the purposes specified in this Ordinance.
