Mr. Kelly stated that he received complaints about a senior banner on a pole on First Ave. that was placed by a resident and not related to the senior athletic/music banners placed on the telephone poles. He has one concern that this banner takes away of the hard work and dedication of the seniors who play sports and/or in the band. His other concern is regarding safety of the individual hanging it on the telephone pole in the right of way. Mayor Rick stated that he would look at the ordinances regarding signage in the residential area.

Mr. Kelly stated that he appreciates that speed sign on Hale. It slows the traffic going to the school and park.


Ms. B. Van Dike reminded everyone of the new field house dedication on Thursday, September 19 at 6:00.


COMMENTS from the Mayor: Limb pickup will be the week of October 7 thru October 11.
