SPONSOR: FINANCE COMMITTEE

A RESOLUTION APPROVING AND AUTHORIZING THE VILLAGE OF MOGADORE TO PARTNER WITH OTHER MUNICIPALITIES, PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE REGIONAL FEMA FIREFIGHTERS ASSISTANCE PROGRAM(S) AND TO EXECUTE CONTRACTS AS REQUIRED, AND DECLARING AN EMERGENCY.

WHEREAS, FEMA has funding available for public works improvements; and,

WHEREAS, the Village of Mogadore, as part of the application process for these funds, has identified the need for the station altering equipment and/or software; and,

WHEREAS, the Village of Mogadore will commit to fund its local 10% share of costs associated with the project; and,

WHEREAS, FEMA provides financial assistance to political subdivisions for safety related equipment and software; and,

WHEREAS, the station alerting equipment and/or software herein above-described is considered to be a priority need for the community.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Portage and Summit, Ohio as follows:

SECTION 1: That the Mayor, Clerk-Treasurer, and Village Fire Chief are authorized to act as a partner in a joint project with other local municipalities to seek funding approval from FEMA for station alerting equipment and/or software.

SECTION 2: The Village of Mogadore will commit to provide its 10% share of the local funding.

SECTION 3: The Mayor, Clerk-Treasurer and/or Fire Chief are hereby authorized to apply to FEMA for funds as described above.

SECTION 4: The Mayor and/or Fire Chief are authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance.

SECTION 5: That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

SECTION 6: That, to the extent not already done so, the funds required for the payment of the obligations incurred are hereby appropriated for the purposes described.

SECTION 7: That this Council hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council which resulted in formal action were taken in meetings open to the public, in full compliance with the applicable legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 8: That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and general welfare of Village residents, to allow for the timely submission of the FEMA application within guidelines and requirements, to allow for the prompt use of this safety equipment and software, and to allow for the continued operations of the Fire Department and other departments and shall, therefore, take effect and be in force from and immediately after its passage.
