A RESOLUTION RETROACTIVELY ESTABLISHING PAY SCALES FOR THE PART-TIME PARKS AND RECREATION PERSONNEL FOR THE VILLAGE OF MOGADORE AND DECLARING AN EMERGENCY

WHEREAS, in order to maintain the efficient operation of the Parks and Recreation Department of the Village of Mogadore, Council deems it necessary to adjust the pay scale for the part-time personnel of the said Department, effective November 1, 2019.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

<u>SECTION 1</u>: The part-time personnel of the Parks and Recreation Department consisting of the Park Laborers and the Recreation Workers shall receive compensation for their services payable bi-weekly in the respective amounts set forth in this Resolution as follows:

```
Level #1 Minimum Wage — New Hire/First year of employment

Solution Sp.00 per hour — One year of employment

Sp.50 per hour — Two years of employment

Level #4 Sp.50 per hour — Three years of employment

Sp.50 per hour — Four years of employment
```

SECTION 2: In addition to Section 1, when the part-time personnel of the Parks and Recreation Department, consisting of the Park Laborers and the Recreation Workers perform work as a part of the Village's Leaf Pick-up Program or other work with the Streets Department, such individuals shall receive compensation for their services payable bi-weekly in the respective amounts as set forth in this Resolution as follows:

Level #1	\$12.00 per hour	_	New Hire/First year of employment
Level #2	\$12.25 per hour	_	One year of employment
Level #3	\$12.50 per hour		Two years of employment
Level #4	\$13.00 per hour	_	Three years of employment
Level #5	\$13.50 per hour	_	Four years of employment
Level #6	\$14.00 per hour		Five or more years of employment

SECTION 3: That this Resolution shall be retroactively effective on November 1, 2019.
