<u>COMMENTS ON THE BILLS</u> – Ms. B. Van Dike made a motion to approve the payment of the bills as presented on the invoice report. Mr. R. McDowall seconded the motion. Vote. Mr. M. Raddish stated he would need to abstain due to one of the checks is payable to himself for a community center security deposit refund. Motion carried with a vote of 5 to 1.

COMMENTS from the Public:

Joe Henico, 3773 Argonne St., asked about the "Children At Play" signs posted between Fenton Ave. and S. Cleveland Ave. He appreciates seeing the signs. He was wondering if council approved installing them thinks they are good idea.

Mayor Rick said that residents asked that the village install the signs and he asked the street department to place them.

A resident from 61 Second Ave. was wondering if the village had any plans for recycling since Republic Services have sent notices that their curbside recycling program was ending.

Mayor Rick stated there were no plans for village sponsored recycling at this time. At the present, council has no intention entering into an agreement for recycling with a hauler. He has heard some haulers are withdrawing from recycling. Portage County does pick up recyclables but will not cross county lines. A few years ago, the village had a collection bin for recycling but due to public abuse with garbage and non-recyclables, had to withdraw from the program.

COMMENTS from Council: Mr. M. Kelly agrees with Mr. Henico regarding the signs. He feels those signs and the speed signs posted within the village deter speeding and is a layer of defense. He feels the signs work.

He asked about a flyer that was handed out to council members regarding marijuana. Ms. B. Van Dike was at a seminar and thought they were informative.
