Ordinance No. 2020-42Passed June 17, 2020

SPONSOR: FINANCE COMMITTEE

A RESOLUTION CREATING A MOGADORE CORONAVIRUS RELIEF FUND, AUTHORIZING AND DIRECTING THE MAYOR AND CLERK-TREASURER TO TAKE ALL NECESSARY ACTIONS TO COMPLY WITH THE REQUIREMENTS OF THE CARES ACT AND S.B. 310 IN EXPENDING FUNDS AND SEEKING REIMBURSEMENT, AND DECLARING AN EMERGENCY

WHEREAS, the Coronavirus Disease 2019 (COVID-19) has had a significant impact on the health and well-being of the residents of Mogadore, and has adversely affected its economy and employment for residents, local businesses, government and non-profit organizations throughout the city/village/township; and,

WHEREAS, the Coronavirus Aid, Relief, and Economic Security Act, 116 Public Law 136 (the CARES Act), was signed into law by the President of the United States on March 27, 2020; and,

WHEREAS, the State of Ohio has enacted H.B. 481, to provide Title V CARES Act funds under the provision for local governments to local subdivisions; and,

WHEREAS, H.B. 481 requires political subdivisions receiving funds under the Act, to pass a resolution affirming that funds from the County Coronavirus Relief Distribution Fund may be expended only to cover costs of the subdivision consistent with the requirements of section 5001 of the CARES Act as described in 42 U.S.C. 601(d), and any applicable regulations before receiving said funds; and,

WHEREAS, pursuant to H.B. 481, funding has been distributed to the County of Summit for further distribution to local political subdivisions; and,

WHEREAS, the H.B. 481 further requires the Village to establish a fund within its treasury named the Local Coronavirus Relief Fund, and it is necessary to authorize the Clerk-Treasurer to create such fund.

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio that:

Section 1: The Clerk-Treasurer is hereby authorized and directed to create a special revenue fund within the accounts of the Village of Mogadore and to name such fund the Local Coronavirus Relief Fund.

Section 2: The Village and Clerk-Treasurer affirm that all funds deposited into this fund shall be used to cover the costs of the subdivision consistent with the requirements of section 5001 of the Coronavirus Aid, Relief, and Economic Security Act, set forth in 42 U.S.C. 601(d) and any regulations applicable thereto, as well as any guidance established by the U.S. Treasury Department and the Auditor of the State of Ohio.

Section 3: The Village affirms it understands that this fund shall be subject to audit by the Auditor of the State of Ohio during its next regular audit under section 117.01 of the Ohio Revised Code.

Section 4: The Village affirms that unencumbered funds, if any, in this account on October 15, 2020 will be paid to the County of Summit Fiscal Officer, who shall deposit the funds in the County Coronavirus Relief Distribution Fund and will proceed under the requirements of H.B. 481.

Section 5: That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

Section 6: That it is found and determined that all formal actions of the Council relating to the adoption of this Ordinance were taken in a duly noticed virtual, open meeting of this Council and that all deliberations which resulted in formal action were taken in meetings open to the public, in full compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code and HB 197 during the state-declared COVID-19 emergency.

Section 7: This Resolution is declared to be an emergency measure necessary for the preservation of the public peace, health, safety, convenience, and welfare of the Village of Mogadore and the inhabitants thereof and in order to properly use the Coronavirus Relief Fund to fund Mogadore's efforts to abate the COVID-19 public health crisis. This Resolution shall be in full force and effect immediately upon its passage and approval by the Mayor.
