

COUNCIL MEETING

June 17, 2020

Council met in regular session at 5:30 p.m. with Mayor Rick presiding.

Motion by Mr. M. Raddish, second by Mr. C. Yoho for the approval of the agenda as presented. Vote. Unanimous ayes. Motion carried.

Motion by Mr. M. Raddish, second by Mr. C. Yoho to adopt the minutes of the June 3, 2020 Council meeting. Vote. Unanimous ayes. Motion carried.

NEW BUSINESS –

Ms. B. Van Dike presented Resolution 2020-42 sponsored by the Finance Committee as follows:

A RESOLUTION CREATING A MOGADORE CORONAVIRUS RELIEF FUND, AUTHORIZING AND DIRECTING THE MAYOR AND CLERK-TREASURER TO TAKE ALL NECESSARY ACTIONS TO COMPLY WITH THE REQUIREMENTS OF THE CARES ACT AND S.B. 310 IN EXPENDING FUNDS AND SEEKING REIMBURSEMENT AND DECLARING AN EMERGENCY

Ms. B. Van Dike made a motion to suspend the rule requiring three readings; Mr. C. Yoho seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Ms. B. Van Dike to adopt Resolution 2020-42; a second was made by Mr. C. Yoho.

Mr. J. Tonsic asked if village funds will be used to open the account. Mr. Varney said that the village would not be funding the account. He stated that there will be a second pool of funds from Summit County and once we know the amount, we will need to reserve 10% of the funds.

Vote. Unanimous ayes. Motion carried.

Mr. M. Raddish presented Resolution 2020-43 sponsored by Mayor Rick as follows:

AN ORDINANCE EXTENDING ORDINANCE NO. 2020-24 UNTIL JULY 31, 2020 AND DECLARING AN EMERGENCY

A motion was made by Mr. M. Raddish to adopt Ordinance 2020-43; a second was made by Ms. K. Miller. Vote. Unanimous ayes. Motion carried.

Mr. J. Tonsic thanked the Mayor and Street Department to open a sewer grate on Marion to free a kitten.

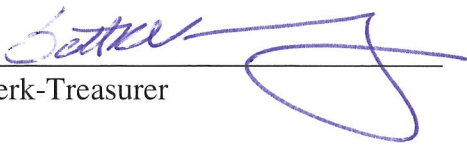
