

COUNCIL MEETING

June 3, 2020

Council met in regular session at 5:30 p.m. with Mayor Rick presiding.

Due to the COVID-19 health crisis and approved emergency measures, council meeting was in session on Facebook Teams format.

Present in council chambers was Mayor Rick, Council President M. Raddish, Council Member B. Van Dike.

Present by remote was Council Members: C. Yoho, R. McDowall, J. Tonsic, M. Kelly, K. Miller, Law Director, M. Pitchford, Clerk-Treasurer, S. Varney and Village Engineer, M. Glass.

Motion by Mr. M. Raddish, second by Ms. B. Van Dike for the approval of the agenda as presented. Vote. Unanimous ayes. Motion carried.

Motion by Mr. M. Raddish, second by Ms. K. Miller to adopt the minutes of the May 20, 2020 Council meeting. Vote. Unanimous ayes. Motion carried.

OLD BUSINESS –

Mr. M. Raddish presented the third reading of Ordinance 2020-35 sponsored by the Planning and Zoning Committee as follows:

AN ORDINANCE AMENDING THE VILLAGE OF MOGADORE CODIFIED ORDINANCES 152.020(B) AND DECLARING AN EMERGENCY

A motion was made by Mr. M. Raddish to adopt Resolution 2020-35, a second was made by Ms. B. Van Dike. Vote. Unanimous ayes. Motion carried.

Mr. M. Raddish presented the third reading of Ordinance 2020-36 sponsored by the Planning and Zoning Committee as follows:

AN ORDINANCE AMENDING THE VILLAGE OF MOGADORE CODIFIED ORDINANCES 152.002-YARD-(3) REAR YARD AND DECLARING AN EMERGENCY

A motion was made by Mr. M. Raddish to adopt Resolution 2020-36, a second was made by Mr. R. McDowall. Vote. Unanimous ayes. Motion carried.

NEW BUSINESS –

Ms. B. Van Dike presented Resolution 2020-40 sponsored by the Finance Committee as follows:

RESOLUTION CREATING FULL-TIME ASSISTANT OFFICE MANAGER POSITION, ESTABLISHING COMPENSATION, AUTHORIZING AND DIRECTING THE MAYOR TO FILL SUCH POSITION AND DECLARING AN EMERGENCY

Ms. B. Van Dike made a motion to suspend the rule requiring three readings; Mr. M. Raddish seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Ms. B. Van Dike to adopt Resolution 2020-40; a second was made by Mr. M. Raddish.

Mayor Rick asked for a motion to amend Section 2 of the Resolution to read “payable bi-weekly” instead “payable semi-monthly.”

Ms. B. Van Dike made a motion to amend the Resolution Section 2 to read “payable bi-weekly” instead “payable semi-monthly.” A second was made by Mr. M. Raddish. Vote. Unanimous ayes. Motion carried.

Mr. J. Tonsic asked how positions/jobs are created in the village. Positions are created by council; they can eliminate positions also.

Vote. Unanimous ayes. Motion carried.

Mr. C. Yoho presented Resolution 2020-41 sponsored by the Streets Committee as follows:

AN ORDINANCE DETERMINING TO PROCEED WITH THE CONSTRUCTION OF THE SIDEWALK IMPROVEMENTS UPON ADJACENT LOTS LOCATED ON PROSPECT STREET AND DECLARING AN EMERGENCY

Mr. C. Yoho made a motion to suspend the rule requiring three readings; Mr. R. McDowall seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Mr. C. Yoho to adopt Ordinance 2020-41; a second was made by Mr. R. McDowall. Vote. Unanimous ayes. Motion carried.

Mr. M. Raddish stated Work Session will be Wednesday, June 24 at 5:30 with all committees reporting.

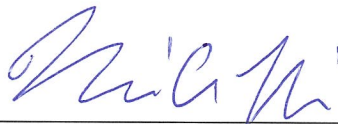

Comments from the Village Engineer: The paving on the northside of Prospect has started.

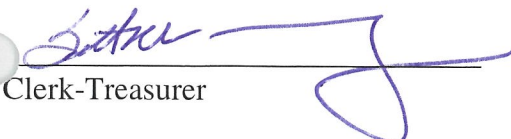
