SPONSOR: SAFETY COMMITTEE

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH SEVERAL CITIES, VILLAGES AND TOWNSHIPS IN SUMMIT COUNTY FOR PURPOSES OF PROVIDING FIRE INVESTIGATION SERVICES AND DECLARING AN EMERGENCY.

WHEREAS, the Cities of Barberton, Green, and New Franklin, and the Villages of Lakemore and Mogadore, and the Townships of Coventry and Springfield wish to enter into a Fire Investigation Cooperation – Memorandum of Understanding; and,

WHEREAS, the Mayor desires to enter into a Memorandum of Understanding with such cities, villages and townships for fire investigation services/cooperation; and,

WHEREAS, it would benefit the health, safety and welfare of the residents of the Village of Mogadore to have fire investigation services/cooperation.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio that:

SECTION 1: That the Mayor is hereby authorized and directed to enter into a Memorandum of Understanding with the Cities of Barberton, Green, and New Franklin, and the Villages of Lakemore and Mogadore, and the Townships of Coventry and Springfield regarding providing fire investigation services/cooperation on behalf of the Village in a form substantially similar to the one attached as Exhibit “A” hereto.

SECTION 2: That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

SECTION 3: That, to the extent not already done so, the funds required for the payment of the obligations incurred are hereby appropriated for the purposes described.

SECTION 4: That it is found and determined that all formal actions of the Council relating to the adoption of this Resolution were taken in a duly noticed virtual, open meeting of this Council and that all deliberations which resulted in formal action were taken in meetings open to the public, in full compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code and HB 197 during the state-declared COVID-19 emergency.

SECTION 5: This Resolution is declared to be an emergency measure necessary for the preservation of the public peace, health, safety, convenience, and welfare of the Village of Mogadore and the inhabitants thereof, and for the further reason that this Resolution must be immediately effective in order to provide for the immediate safety services provided for herein, which are necessary to preserve and protect the residents and interests of the Village. This Resolution shall be in full force and effect immediately upon its passage and approval by the Mayor.
