

Council met in regular session at 5:30 p.m. with Mayor Rick presiding.

Due to COVID-19, the Council Meeting was moved to the Pry Community Center for safe distancing. Council members could remote into the meeting if they chose to do so. Also, the meeting was opened to the public.

Motion by Mr. M. Raddish, second by Mr. M. Kelly to adopt the minutes of the September 2, 2020 Council meeting. Vote. Unanimous ayes. Motion carried.

NEW BUSINESS –

Ms. B. Van Dike presented Ordinance 2020-63 sponsored by the Finance Committee as follows:

AN ORDINANCE AMENDING THE ANNUAL APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE FOR THE FISCAL YEAR ENDING DECEMBER 31, 2020 AND DECLARING AN EMERGENCY

Ms. B. Van Dike presented Resolution 2020-64 sponsored by Finance Committee as follows:

RESOLUTION AUTHORIZING THE TRANSFERS WITHIN FUNDS AND DECLARING AN EMERGENCY

Ms. B. Van Dike made a motion to suspend the rule requiring three readings; Mr. M. Kelly seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Mr. B. Van Dike to adopt Resolution 2020-64; a second was made by Mr. M. Kelly. Vote. Unanimous ayes. Motion carried.

COMMENTS from the Public: Mr. J. Henico, 3773 Argonne; inquired about legislation passed regarding Mayor Court raising rates. He wanted to know if we could have had a laddered scale according to the violators' income.

Law Director Pitchford stated he is not aware of any municipality that has separate scales for fines and he thinks it would be unconstitutional to do so.

Mr. M. Raddish said Mayor Court has a payment plan to help the offenders in paying the fine.

Mr. J. Mencer, 242 S. Cleveland asked why there has been quite a few trucks with over-size loads traveling on S. Cleveland. Mr. C. Yoho stated it could be a traffic detour for the Canton Road project.

COMMENTS from the Council:

Mr. R. McDowall replied to Mr. Henico's question regarding a sliding scale for Mayor Court costs, Yellow Springs, Ohio has a sliding scale.

He also reminded everyone to respond to the census questionnaire. It is very important to be counted.

Mayor Rick stated the last notification, 82.5% of the village population has replied to the census.

Mr. M. Raddish thanked the residents for coming to the meeting this evening.


Law Director: No comments.

Meeting adjourned at 5:48 p.m.


