

## RECORD OF ORDINANCES

Ordinance No. 2020-82Passed November 18, 2020

SPONSOR: FINANCE COMMITTEE

AN ORDINANCE AMENDING THE ANNUAL APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE FOR THE FISCAL YEAR ENDING DECEMBER 31, 2020 AND DECLARING AN EMERGENCY.

NOW, THEREFORE BE IT ORDAINED, by the Council of the Village of Mogadore, counties of Summit and Portage, State of Ohio, that:

SECTION 1: Findings and Determinations. This Council finds and determines the following matters:

- a) It is necessary to make annual appropriations to provide for current expenses and other expenditures of the Village for the fiscal year ending December 31, 2020.
- b) All formal actions of this Council relating to the enactment of this Ordinance were taken in a duly noticed virtual, open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in those formal actions were in meetings open to the public in compliance with the law, including Section 121.22, Ohio Revised Code during the state-declared COVID-19 emergency.

SECTION 2: Amended Appropriations. This Council amends the following sums for the current expenses and other expenditures of the Village for the fiscal year ending December 31, 2020, from the various funds of the Village, as follow

SECTION 4: That is found and determined that all formal actions of the Council relating to the adoption of this Resolution were taken in a duly noticed virtual, open meeting of this Council and that all deliberations which resulted in formal action were taken in meetings open to the public, in full compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code and HB 197 during the state-declared COVID-19 emergency.

SECTION 5: This Ordinance is an emergency measure necessary for the preservation of the public peace, health, safety, and welfare of the Village of Mogadore and the inhabitants to establish the Village's annual appropriations and to set aside the necessary funds in order to ensure the timely performance of the Village operations and the timely payment of Village current expenses and obligations during the period January 1, 2020 through December 31, 2020 and provided this Ordinance receives the approval of two-thirds of the members of Council, shall be in full force and effect from and after its passage and approval by the Mayor, or otherwise take effect and be in full force from and after the earliest period allowed by law.
