A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH KIMBLE RECYCLING & DISPOSAL, INC. FOR THE EXCLUSIVE RIGHT TO PROVIDE TRASH HAULING WITHIN THE VILLAGE; AND DECLARING AN EMERGENCY

WHEREAS, the voters of Mogadore approved an amendment to the Village Charter allowing for the ability to have one provider of solid waste disposal and recycling; and,

WHEREAS, a Request for Proposal process has been completed and two service providers submitted bids; and,

WHEREAS, Kimble Recycling & Disposal, Inc. submitted the bid with the lowest and best pricing; and,

WHEREAS, any irregularities in such bid submission are insignificant and should be and are waived; and,

WHEREAS, this Council finds it appropriate and necessary to enter into an agreement with Kimble Recycling & Disposal, Inc. for the exclusive right to provide trash hauling within the Village.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Portage and Summit, Ohio as follows:

<u>SECTION 1</u>: That the Mayor of the Village of Mogadore is hereby authorized to enter into an agreement with Kimble Recycling & Disposal, Inc. for the exclusive right to provide trash hauling within the Village so long as it is consistent with the company's bid submission and the Village administration's requirements.

<u>SECTION 2</u>: That the Mayor and Clerk-Treasurer are hereby authorized to sign and process all necessary paperwork to effectuate the entering of, execution and implementation of said agreement.

<u>SECTION 3</u>: That, to the extent not already done so, the funds required for the payment of the obligations incurred are hereby appropriated for the purposes described.

<u>SECTION 4:</u> That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.
