A RESOLUTION AMENDING RESOLUTION NO. 2019-48 EXHIBIT "A" AND SECTION 2, PROVIDING PAY SCALE AND BENEFITS FOR VILLAGE FIRE OFFICERS AND FIREFIGHTERS AND DECLARING AN EMERGENCY

WHEREAS, Pursuant to the recommendation of the Mayor and the Finance/Audit Committee, the pay scale for Fire Department personnel shall be increased by 2%.

WHEREAS, Pursuant to the recommendation of the Mayor and the Finance/Audit Committee, the overnight pay scale for Fire Department personnel shall be eliminated and standard rates, as applicable to each member of the Fire Department shall apply.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

SECTION 1: That Exhibit "A" to Resolution 2019-48 be replaced in its entirety with Exhibit "A" hereto. The terms and conditions of the new wage and benefit package for the Village Fire Officers and Firefighters are set forth in their entirety in Exhibit "A" attached hereto, which is incorporated herein by reference.

SECTION 2: That Section 3 of Resolution 2019-48 be amended to state as follows:

This Resolution shall be effective as of January 16, 2021.

SECTION 3: All other ordinances, resolutions, or parts of other ordinances and resolutions which may be in conflict with the provisions of this Resolution are hereby declared null and void and are of no further force and effect.

SECTION 4: The Village of Mogadore finds and determines that all formal actions of this Council concerning and relating to the adoption of this resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in this formal action were in meetings open to the public, in compliance with all legal requirements.

SECTION 5: That it is found and determined that all formal actions of the Council relating to the adoption of this Resolution were taken in a duly noticed virtual, open meeting of this Council and that all deliberations which resulted in formal action were taken in meetings open to the public, in full compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code and HB 197 during the state-declared COVID-19 emergency.
