SPONSOR: PLANNING AND ZONING COMMITTEE

AN ORDINANCE RETROACTIVELY AMENDING THE VILLAGE OF MOGADORE CODIFIED ORDINANCE SECTIONS 116.07(B) and (C) TO ADJUST THE ANNUAL FEE FOR SKLLED GAMING LOCATIONS FOR 2021 AND THE REMAINING FEES FOR SKILLED GAMING FACILITIES FOR A PERIOD OF SIX MONTHS, AND ALLOWING MONTHLY PAYMENTS, AND DECLARING AN EMERGENCY.

WHEREAS, this Council finds it appropriate and necessary to retroactively amend C.O. 116.07 to adjust the fees for skilled gaming facilities for a period of six months; and,

WHEREAS, it is in the best interests of and furthers the public peace, health, safety, and general welfare of the Village residents to amend Section 116.07(B) and (C) of the Village of Mogadore's Codified Ordinances as a result of the COVID 19 pandemic and to create Section 116.07(H) regarding the monthly payment of fees.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Mogadore, Counties of Portage and Summit, Ohio, as follows:

- <u>SECTION 1</u>: That effective January 1, 2021, retroactively, the Village of Mogadore Codified Ordinances Section 117.06(B) be hereby amended to state, "A fee of \$2,500 per arcade location per year has been paid in conformity with this Section 116.07;"
- SECTION 2: That effective January 1, 2021, retroactively, the Village of Mogadore Codified Ordinances Section 117.06(C) be hereby amended to state, "A fee of \$50 per machine per month has been paid has been paid in conformity with this Section 116.07;"
- SECTION 3: That effective July 1, 2021, the Village of Mogadore Codified Ordinances Section 117.06(C) be hereby amended to state, "A fee of \$100 per machine per month has been paid has been paid in conformity with this Section 116.07;"
- <u>SECTION 4</u>: That effective January 1, 2021, retroactively, the Village of Mogadore Codified Ordinances Section 117.06(H) be hereby created and shall state, "The fees provided for under Subsections (B) and (C) may be paid annually in lump sum or on a monthly basis with One-twelfth (1/12) of the annual fee under Subsection (B) being due each month."
- SECTION 5: The amendment under the aforesaid Section 1 shall remain effect until December 31, 2021 at 11:59 p.m. At 12:00 a.m. January 1, 2022, the original language of Section 116.07(B) shall be restored. The amendment under the aforesaid Section 2 shall remain effect until June 30, 2021 at 11:59 p.m. The amendments under the aforesaid Sections 3 and 4 shall not expire unless and until further act and legislation by this Council.
- <u>SECTION 6</u>: That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Ordinance.
