

## COUNCIL MEETING

January 20, 2021

Council met in regular session at 5:30 p.m. with Mayor Rick presiding.

Mr. M. Raddish asked everyone to join him in a moment of reflection for their own intentions. The Pledge of Allegiance to the Flag was recited by all.

Due to COVID-19, the Council Meeting was moved to the Pry Community Center for safe distancing. Council members could remote into the meeting if they chose to do so. Also, the meeting was opened to the public.

Present at the community center in council chambers was Mayor Rick, Council Members: Ms. K. Miller, and Mr. M. Raddish, and Ms. B. Van Dike.

Present by remote was Council Members: Mr. R. McDowall, Mr. C. Yoho, and Mr. J. Tonsic, Law Director, Marshal Pitchford, Clerk-Treasurer, Scott Varney, and Village Engineer, Matthew Glass.

Motion by Mr. M. Raddish, second by Mr. C. Yoho for the approval of the agenda as presented. Vote. Unanimous ayes. Motion carried.

Motion by Mr. M. Raddish, second by Ms. K. Miller to adopt the minutes for the January 6, 2021 Council meeting. Vote. Unanimous ayes. Motion carried.

COMMENTS FROM THE AUDIENCE ON PENDING LEGISLATION – Mr. Jon Mencer, 242 South Cleveland Avenue, asked if the Lampion invoice from Resolution 2021-6 was paid by the Village or insurance. Mayor Rick stated the driver's insurance company paid for the replacement of the light months ago.

### COMMITTEE REPORTS –

UTILITIES – Mr. Tonsic had one Ordinance to read.

SAFETY – No report.

PARKS – Mr. McDowall had no report.

PLANNING AND ZONING – Ms. Miller had no report.

FINANCE/AUDIT – Ms. Van Dike has one Resolution to read.

STREETS – Mr. Yoho has one Resolution to read.

Mr. M. Raddish announced the next Work Session will be held Wednesday, January 27, 2021 at 5:30 p.m. with all committees reporting.

OLD BUSINESS – None.

### NEW BUSINESS –

Mr. C. Yoho presented Resolution 2021-5 sponsored by the Street Committee as follows:

**A RESOLUTION AUTHORIZING THE MAYOR OF THE VILLAGE OF MOGADORE TO ENTER INTO AN AGREEMENT WITH THE SUMMIT COUNTY COMBINED GENERAL HEALTH DISTRICT**

(SUMMIT COUNTY PUBLIC HEALTH) TO PROVIDE STORM WATER MANAGEMENT SERVICES AND DECLARING AN EMERGENCY.

Mr. C. Yoho made a motion to suspend the rules requiring three readings; Ms. K. Miller seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Mr. C. Yoho to adopt Resolution 2021-5, a second was made by Ms. B. Van Dike.

Mayor Rick stated this was a reduction in fees compared to previous years.

Vote. Unanimous ayes. Motion carried.

Ms. B. Van Dike presented Resolution 2021-6 sponsored by Finance Committee as follows:

A RESOLUTION AUTHORIZING THE CLERK TREASURER, PURSUANT TO R.C. 5705.41(D), TO ISSUE A WARRANT OF PAYMENT TO LAMPION COMPANIES, LLC, IN THE AMOUNT OF \$7,395 AND DECLARING AN EMERGENCY.

Ms. B. Van Dike made a motion to suspend the rules requiring three readings; Mr. C. Yoho seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Ms. B. Van Dike to adopt Resolution 2021-6; a second was made by Mr. C. Yoho.

Mayor Rick stated this is the replacement light at the corner of South Cleveland and Albrecht Avenue.

Vote. Unanimous ayes. Motion carried.

Mr. J. Tonsic presented Ordinance 2021-7 sponsored by the Utilities Commission as follows:

AN ORDINANCE ESTABLISHING SECTION 50.15(C) OF THE VILLAGE OF MOGADORE CODIFIED ORDINANCES REGARDING IMPROPER BILLING BY TRASH HAULERS AND RELATED ADMINISTRATIVE FINES AND DECLARING AN EMERGENCY.

Mr. J. Tonsic made a motion to suspend the rules requiring three readings; Ms. K. Miller seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Mr. J. Tonsic to adopt Ordinance 2021-7; a second was made by Ms. K. Miller.

Mayor Rick stated this is prohibiting trash companies to charge any penalties or administrative fees when a resident cancels their trash service. Companies also cannot charge for services not rendered yet.

Vote. Unanimous ayes. Motion carried.

DISCUSSION AND VOTE FOR NEW COUNCIL MEMBER-

Ms. B. Van Dike made a motion to appoint Bob Schrock to open seat on Council; Mr. M. Raddish seconded the motion.

Council discussed the two candidates that submitted their letter of interest. Council felt both applicants, Bob Schrock and Mike Berger would be good candidates.

Vote. Unanimous. Motion carried.

COMMENTS from the Public: Bob Schrock thanked Council for allowing him to serve on Mogadore's Council.

COMMENTS from Council: Welcomed Bob Schrock back as a member of Council.


COMMENTS from the Law Director: No comments.

COMMENTS from the Mayor: Mayor Rick repeated his earlier comments about the trash hauler information regarding Ordinance 2021-7.


