Resolution No. 2021-20Passed APRIL 7, 2021

SPONSOR: SAFETY COMMITTEE

RESOLUTION AND ORDER AUTHORIZING THE MAYOR AND/OR HIS DESIGNEE TO ENTER INTO A CHANGE ORDER WITH BECK ELECTRIC COMPANY AND DECLARING AN EMERGENCY.

WHEREAS, upon the recommendation of the Village Engineer, Council previously found necessary and accepted the bid from Beck Electric Company for supplying labor and materials necessary for a generator to power the Police Station, Fire Station and Administrative Offices, in an amount of \$75,100.00; and,

WHEREAS, Council previously found necessary and accepting a Change Order for additional gas piping for an additional amount of \$5,668.35; and

WHEREAS, Beck Electric Company has issued another Change Order for gravel and weed guard for an additional amount of \$445.00; and,

WHEREAS, the Village Engineer has reviewed the Change Order and feels it is reasonable and necessary; and,

NOW, THEREFORE BE IT RESOLVED, by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

SECTION 1: The Mayor, Clerk-Treasurer, and Village Engineer are hereby authorized and directed to execute any and all paperwork and do all things necessary to approve and implement the aforesaid additional change order for gravel and weed guard with Beck Electric Company.

SECTION 2: That, to the extent not already done so, the funds required for the payment of the obligations incurred are hereby appropriated for the purposes described.

SECTION 3: That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

SECTION 4: It is hereby determined necessary, proper, and in the best interests of the Village of Mogadore and its residents that the Village of Mogadore enter into the change order with Beck Electric Company for gravel and weed guard in connection with the Village's new generator.

SECTION 5: That it is found and determined that all formal actions of the Council relating to the adoption of this Resolution were taken in a duly noticed virtual, open meeting of this Council and that all deliberations which resulted in formal action were taken in meetings open to the public, in full compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code and HB 404 during the state-declared COVID-19 emergency.
