COMMENTS from the Law Director: Marshal Pitchford gave Council an update on the legal process of the property located at 3764 Mogadore Road.

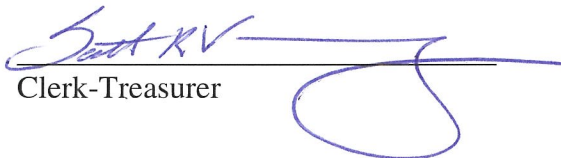
