Ordinance No. 2021-59Passed NOVEMBER 3, 2021

SPONSOR: SAFETY COMMITTEE

A RESOLUTION AUTHORIZING THE MAYOR ENGAGE “IN COMMAND IN COACHING & CONSULTNG, LLC” TO WRITE A GRANT FOR THE STAFFING FOR ADEQUATE FIRE AND EMERGENCY RESPONSE (S.A.F.E.R.) GRANT FUNDS AND TO APPLY FOR THE PROGRAM AND DECLARING AN EMERGENCY.

WHEREAS, the Village Fire Department desires to apply for the Federal Emergency Management Agency’s Staffing For Adequate Fire and Emergency Response (“S.A.F.E.R.”) grant funds and wishes to engage the “In Command Coaching & Consulting, LLC” firm for the purpose of preparing the grant application; and

WHEREAS, it is in the best interests of the Village to engage this firm to write and submit the grant application properly and in a timely fashion.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Portage and Summit, Ohio, as follows:

SECTION 1: That it is in the best interests of the Village of Mogadore and Mogadore Fire Department to apply for and secure the grant funds of the Federal Emergency Management Agency S.A.F.E.R. Grant Program for the Mogadore Fire Department.

SECTION 2: That the Mayor, Clerk-Treasurer and/or his designee are authorized to enter into a contact, in an amount up to \$2,500.00, with “In Command Coaching & Consulting, LLC” to prepare the Village’s grant application, including narratives, for the Fiscal Year 2021 S.A.F.E.R. Grant Program.

SECTION 3: That the Mayor, Clerk-Treasurer and/or the Mayor’s designee are hereby authorized to sign and file the S.A.F.E.R. grant application prepared by “In Command Coaching & Consulting, LLC” on behalf of the Village of Mogadore’s Fire Department.

SECTION 4: That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

SECTION 5: The Village of Mogadore finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in this formal action were in meeting open to the public, in compliance with all legal requirements.

SECTION 6: That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety of the Village residents, for the immediate engagement of the “In Command” firm so an application for the S.A.F.E.R grant can be timely submitted, and to allow for the continued operations of the Village Service Department and other departments and shall therefore take effect and be in force from and immediately after its passage.
