Resolution No. 2022-15

SPONSOR: SAFETY COMMITTEE

A RESOLUTION AUTHORIZING THE MAYOR TO SELL UNNEEDED PERSONAL PROPERTY, BEING THE BOSS SNOWPLOW, AND DECLARING AN EMERGENCY.

WHEREAS, the Village owns personal property, i.e. a Boss 6.5 foot snow plow, that it no longer needs and now desires to sell;

WHEREAS, it is in the best interests of the Village to sell the foregoing property as it is presently being under-utilized and counterproductive for the needs of the Village at this time; and,

WHEREAS, the Village has previously authorized the sale of such property by online auction.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Portage and Summit, Ohio, as follows:

SECTION 1: That it is in the best interests of the Village of Mogadore and its operations to sell unfit, obsolete and/or unneeded personal property, which is the aforesaid plow.

SECTION 2: This identified personal property is hereby found to be unneeded.

SECTION 3: That the Mayor, Clerk-Treasurer and/or the Mayor's designee are hereby authorized and directed to sell the aforesaid personal property in a reasonably commercial fashion, more specifically on Govdeals.com as previously authorized and contracted.

SECTION 4: That the internet auction shall satisfy the statutory minimum of ten (10) days (including Saturdays, Sundays and legal holidays) for bidding on the property.

SECTION 5: Advertising for the internet auction is hereby directed and shall be accomplished in accordance with the Ohio Revised Code and the Mogadore legislation on this topic.

SECTION 6: That no proceeds from the internet sales shall be paid in cash, rather all proceeds shall be delivered to the Clerk-Treasurer by cashier or bank check, or electronic transfer to the Village's general fund with verification of receipt delivered to the Clerk-Treasurer.

SECTION 7: That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

SECTION 8: That it is found and determined that all formal actions of the Council relating to the adoption of this Resolution were taken in a duly noticed virtual, open meeting of this Council and that all deliberations which resulted in formal action were taken in meetings open to the public, in full compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 9: That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety of the Village residents and to allow for the continued operations of the Village Fire Department and other departments and shall therefore take effect and be in force from and immediately after its passage.
