SPONSOR: PARKS COMMITTEE

A RESOLUTION APPROVING AND AUTHORIZING THE VILLAGE OF MOGADORE TO ACCEPT THE COMMUNITY BLOCK GRANT FOR THE RECONSTRUCTION OF THE LIONS PARK PICKLEBALL COURTS, AND DECLARING AN EMERGENCY.

WHEREAS, Summit County has awarded grant funds for the improvements; and,

WHEREAS, the Village of Mogadore, as part of the application process for these funds, has identified the need for the reconstruction of the Lions Park pickleball courts; and,

WHEREAS, the Village of Mogadore has committed to fund its local share of costs associated with the improvement; and,

WHEREAS, the Community Development Block Grant Program provides financial assistance to political subdivisions for capital improvements to public infrastructure; and,

WHEREAS, the Village of Mogadore is planning to make capital improvements to the Lions Park pickleball courts; and,

WHEREAS, the infrastructure improvement herein above-described is considered to be a priority need for the community.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Portage and Summit, Ohio as follows:

SECTION 1: The Village of Mogadore will commit to provide its share of the local funding through general notes and bonds to construct the improvements.

SECTION 2: The Mayor and/or Village Engineer are hereby authorized to accept the grant funds as described above.

SECTION 3: The Mayor and/or Village Engineer are authorized to enter into any agreements and sign any documents as may be necessary and appropriate for the design and construction services related to the proposed improvements.

SECTION 4: That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

SECTION 5: That, to the extent not already done so, the funds required for the payment of the obligations incurred are hereby appropriated for the purposes described.

SECTION 6: That it is found and determined that all formal actions of the Council relating to the adoption of this Resolution were taken in a duly noticed virtual, open meeting of this Council and that all deliberations which resulted in formal action were taken in meetings open to the public, in full compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 7: That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and general welfare of Village residents, to allow for the timely acceptance of the Community Development Block Grant Program application within guidelines and requirements, to allow for the prompt remediation efforts to begin when the weather will first allow, and to allow for the continued operations of the Village Administration and other departments and shall, therefore, take effect and be in force from and immediately after its passage.
