A RESOLUTION APPROVING AND AUTHORIZING THE VILLAGE OF MOGADORE TO ACCEPT THE COMMUNITY BLOCK GRANT FOR THE RECONSTRUCTION OF THE LIONS PARK PICKLEBALL COURTS, AND DECLARING AN EMERGENCY.

WHEREAS, Summit County has awarded grant funds for the improvements; and,

WHEREAS, the Village of Mogadore, as part of the application process for these funds, has identified the need for the reconstruction of the Lions Park pickleball courts; and,

WHEREAS, the Village of Mogadore has committed to fund its local share of costs associated with the improvement; and,

WHEREAS, the Community Development Block Grant Program provides financial assistance to political subdivisions for capital improvements to public infrastructure; and,

WHEREAS, the Village of Mogadore is planning to make capital improvements to the Lions Park pickleball courts; and,

WHEREAS, the infrastructure improvement herein above-described is considered to be a priority need for the community.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Portage and Summit, Ohio as follows:

<u>SECTION 1</u>: The Village of Mogadore will commit to provide its share of the local funding through general notes and bonds to construct the improvements.

<u>SECTION 2</u>: The Mayor and/or Village Engineer are hereby authorized to accept the grant funds as described above.

SECTION 3: The Mayor and/or Village Engineer are authorized to enter into any agreements and sign any documents as may be necessary and appropriate for the design and construction services related to the proposed improvements.


<u>SECTION 4</u>: That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.
