Council Meeting was held in Council Chambers. The meeting was open to the public and face masks were required by all.

Motion by Mr. M. Raddish, second by Mr. W. Bauer for the approval of the agenda as presented. Vote. Unanimous ayes. Motion carried.

Motion by Mr. M. Raddish, second Mr. W. Bauer to adopt the minutes for February 2, 2022, Council meeting. Vote. Unanimous ayes. Motion carried.

NEW BUSINESS-

Mr. R. McDowall presented Resolution 2022-**18** sponsored by Finance Committee as follows:

A RESOLUTION APPROVING AND AUTHORIZING THE VILLAGE OF MOGADORE TO ACCEPT THE COMMUNITY BLOCK GRANT FOR THE RECONSTRUCTION

Mr. R. McDowall made a motion to suspend the rules requiring three readings; Mr. J. Tonsic seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Mr. R. McDowall to adopt Resolution 2022-18, a second was made by Mr. J. Tonsic.

Mayor Rick stated that twenty-five percent of the cost the Village is responsible for will come out of the American Recovery Act fund.

Vote. Unanimous ayes. Motion carried.

COMMENTS from the Public: Carl Housely, 67 First Avenue, voiced his concern about the 3.5 MIL Tax Levy for the Fire Department. Housely stated his property tax will increase by twenty-five percent in Portage County.

Noris Hale, 204 S Cleveland Avenue, clarified what she stated a few meetings back regarding the ordinance on snow removal for the sidewalks. Hale said the Village does have an ordinance for snow removal from sidewalks and she would like to see it enforced. Hale also asked if she could see the drawing of the pickleball courts for current resolution 2022-18 that was not included in the packets. Mayor Rick said he would show her a copy after the meeting was over.

COMMENTS from Council: President Mr. R. Raddish stated he approves of the pickleball courts.

COMMENTS from the Law Director: Mr. Pitchford provided an update on the legal process at 3764 Mogadore Road.


