Matt Glass stated the trail will be half a mile long and there is not a set date because we have not applied for the grant yet. Legislation that passed will let us apply and accept that grant.

Jacqueline Tycast, 3767 Prospect Street, asked where the new trail will be at the park.

Mayor Rick stated the new trail would mirror the trail that is already down there. It will be in the back of the park and go around the baseball field and come out by the playground area by pickleball and baseball courts. The new trail will be asphalt.

COMMENTS from Council: Mr. Yoho mentioned there are a few trees down at the park that have low hanging branches.

Mayor Rick stated the Street Department is already working on getting those cut down.
