RESOLUTION RETROACTIVELY ESTABLISHING PAY SCALES FOR PART-TIME PARKS MAINTENANCE PERSONNEL, PART-TIME PARKS MAINTENANCE SUPERVISOR, PART-TIME PARKS MAINTENANCE ASSISTANT SUPERVISOR, PART-TIME PARKS RECREATION SUPERVISOR, PART-TIME PARKS RECREATION ASSISTANT SUPERVISOR, AND PART-TIME CEMETERY MAINTENANCE PERSONNEL AND DECLARING AN EMERGENCY.

BE IT RESOLVED, by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

SECTION 1: Based on the recommendations of the Finance Committee the part-time Park's Maintenance Personnel, the part-time Park's Maintenance Supervisor, the part-time Park's Maintenance Assistant Supervisor, the part-time Park's Recreation Supervisor, the part-time Park's Recreation Assistant Supervisor, and the part-time Cemetery Maintenance Personnel shall receive compensation for their services at a rate between the applicable State of Ohio minimum wage and amount not to exceed Fifteen Dollars (\$15.00) per hour, payable bi-weekly. The precise amount to the individuals filling these positions shall be set by the Mayor.

SECTION 2: In addition to Section 1, when the part-time personnel of the Parks Maintenance Program and the Cemetery Maintenance Program perform work as part of the Village's Leaf Pick-up Program or other work with the Streets Department, such individuals shall receive compensation for their services at an additional rate of \$3.00 more hourly than their assigned compensation.

SECTION 3: This Resolution and these pay rates shall be effective, retroactively, as of March 1, 2022.

SECTION 4: All formal actions of this Council related to this Resolution and all deliberations of the Council and of any of its Committees that resulted in such formal action were inmeetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5: This Resolution is hereby declared to be an emergency measure to assure the continuance of the Parks Recreation program, the Parks Maintenance program, and the Cemetery Maintenance department in progress and for the immediate preservation of the public peace, health, and safety of the residents of the Village of Mogadore and shall take effect and be in force upon its passage by Council and approval by the Mayor.
