Ordinance No. 2022-35

Passed APRIL 20, 2022

SPONSOR: PARKS COMMITTEE

AN ORDINANCE ADOPTING THE VILLAGE OF MOGADORE SPECIAL EVENTS GUIDEBOOK, APPLICATION FORM AND FEE SCHEDULE, AND DECLARING AN EMERGENCY.

WHEREAS, the Village Council has reviewed the attached Village of Mogadore Special Events Guidebook and believes it regulates Special Events in a manner that protects the financial interests of the Village, protects the health, safety, and welfare of the Village residents, and will provide for an orderly and safe event experience for applicants and attendees; and

WHEREAS, the Village Council has reviewed the Village of Mogadore Special Events Fees schedule and believes that it provides for the financial needs of the Village and its' residents in the processing of the application and preparing for Special Events.

NOW, THEREFORE, BE IT ORDAINED by the Village Council of Mogadore, Summit and Portage Counties, State of Ohio, that:

SECTION 1: The Village of Mogadore Special Events Guidebook, which is attached hereto as Exhibit "A," is hereby adopted, incorporated herein and creates a procedure for scheduling and conducting Special Events in the Village of Mogadore.

SECTION 2: The Village of Mogadore Special Events Fees schedule, attached as Exhibit "B" and incorporated herein, sets the application fees and the costs of using Village resources for Special Events in the Village.

SECTION 3: The Village of Mogadore finds and determines that all formal actions of this Council concerning and relating to the adoption of this resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in this formal action were in meeting open to the public, in compliance with all legal requirements, including R.C.121.22.

SECTION 4: That the recitals set forth above are incorporated by reference herein.

SECTION 5: This Ordinance is an emergency measure necessary for the preservation of the public peace, health, safety, convenience, and welfare of the Village of Mogadore and the inhabitants thereof, and permits the Village to immediately implement these rules, policies and procedures in light of the upcoming concert season and warmer weather, and provided it receives the approval of two-thirds of the members of Council, shall be in full force and effect from and after its passage and approval by the Mayor, or otherwise take effect and be in full force from and after the earliest period allowed by law.

## Special Event Application Fees

Late Fee - Application submitted less than <b>180 days</b>	\$100
Late Fee - Application submitted less than <b>90 days</b>	\$200

## Electrical Fees

110 volt	\$35/day
220 volt	\$70/day

## Police Special Duty

The number of required officers is coordinated through the Village of Mogadore Police Department. Officer support and vehicle rentals require a three (3) hour minimum.

Police Personnel	\$35.00/hr, 3 hr minimum
Police Vehicles	\$20.00/hr, 3 hr minimum
Week day Traffic Direction/Control	\$40.00/hr, 3 hr minimum
Weekend Traffic Direction/Control	\$50.00/hr, 3 hr minimum

## Fire – EMS

The number of required staff is coordinated through the Village of Mogadore Fire Department. Fire support and vehicle rentals require a four (4) hour minimum.

Firefighter	\$35.00/hr, 3 hr minimum
Medic	\$35.00/hr, 3 hr minimum
Fire Inspector	\$35.00/hr, 3 hr minimum
Medic Vehicle	\$41.76/hr, 3 hr minimum
Fire Engine	\$25.00/hr, 3 hr minimum
Ladder Truck	\$25.00/hr, 3 hr minimum
Rescue Truck	\$25.00/hr, 3 hr minimum
