AN ORDINANCE ESTABLISHING RENTAL FEES FOR THE PRY COMMUNITY CENTER AND APPROVING THE APPLICATION FORM AND CONTRACT, AND DECLARING AN EMERGENCY

WHEREAS, the Russell M. Pry Community Center is a great resource in the Village which is utilized by members of the community frequently; and,

WHEREAS, it is imperative that the Village establish rental fees and a form application and contract for the use of the facilities in order to create uniformity in rental policy and use, to protect and preserve the facilities, and to protect the Village from liability.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

<u>SECTION 1</u>: That the following rental fees and security deposit for the Russell M. Pry Community Center are established and adopted:

Resident Rental Fee:	\$100
Resident Security Deposit:	\$100

(to be returned after rental as appropriate)

Non-resident Rental Fee: \$250 Non-resident Security Deposit: \$200

(to be returned after rental as appropriate)

SECTION 2: That the Rental Agreement and Lease, Waiver and Indemnity Agreement, attached hereto as Exhibit "A" and incorporated herein, is hereby adopted and approved for use as a part of the policies and procedures surrounding the use of the Russell M. Pry Community Center. The form may be modified at any time by the Mayor with the approval of the Law Director so long as the fees and security deposit remain consistent with this Ordinance.

SECTION 3: That this Ordinance shall be effective as of April 15, 2022. Any rental agreements made prior to that date shall be subject to the prior rules and regulations. Any reservation made on April 15, 2022 or thereafter are subject to the terms of this Ordinance and shall be made pursuant to the attached form.

SECTION 4: That the recitals set forth above are incorporated by reference herein.

SECTION 5: All other ordinances, resolutions, or parts of other ordinances and resolutions which may be in conflict with the provisions of this ordinance are hereby declared null and void and are of no further force and effect.
