NEW BUSINESS-

Ms. B. Van Dike presented Ordinance 2022-31 sponsored by Finance Committee as follows:

AN ORDINANCE AMENDING THE ANNUAL APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE FOR THE FISCAL YEAR ENDING DECEMBER 31, 2022, AND DECLARING AN EMERGENCY.

A motion was made by Ms. B. Van Dike to adopt Ordinance 2022-31, a second was made by Mr. R. McDowall. Vote. Unanimous ayes. Motion carried.

Mr. J. Tonsic presented Resolution 2022-32 sponsored by Streets Committee as follows:

RESOLUTION AUTHORIZING THE CLERK-TREASURER TO ADVERTISE FOR BIDS FOR LABOR AND MATERIALS FOR NECESSARY 2022 CHIP AND SEAL STREET REPAIRS WITHIN THE VILLAGE OF MOGADORE AND DECLARING AN EMERGENCY.

Mr. R. McDowall presented Ordinance 2022-33 sponsored by Parks Committee as follows:

AN ORDINANCE AMENDING THE VILLAGE OF MOGADORE CHAPTER 113 "COMMERCIAL AMUSEMENTS," AND CREATING THE VILLAGE OF MOGADORE CHAPTERS 119 AND 120 "SPECIAL EVENTS" AND "MOBILE FOOD TRUCKS," AND DECLARING AN EMERGENCY.

Mr. R. McDowall made a motion to suspend the rules requiring three readings; Ms. B. Van Dike seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Mr. R. McDowall to adopt Ordinance 2022-33, a second was made by Mr. J. Tonsic. Vote. Unanimous ayes. Motion carried.

Mr. R. McDowall presented Ordinance 2022-34 sponsored by Parks Committee as follows:

AN ORDINANCE AMENDING THE VILLAGE OF MOGADORE CODIFIED ORDINANCES, SECTION 132.13, TITLED "SAFETY OF CROWDS ATTENDING SPECIAL EVENTS," AND DECLARING AN EMERGENCY.

Mr. R. McDowall made a motion to suspend the rules requiring three readings; Mr. J. Tonsic seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Mr. R. McDowall to adopt Ordinance 2022-34, a second was made by Ms. B. Van Dike. Vote. Unanimous ayes. Motion carried.

Mr. R. McDowall presented Ordinance 2022-35 sponsored by Parks Committee as follows:

AN ORDINANCE ADOPTING THE VILLAGE OF MOGADORE SPECIAL EVENTS GUIDEBOOK, APPLICATION FORM AND FEE SCHEDULE, AND DECLARING AN EMERGENCY.

Mr. R. McDowall made a motion to suspend the rules requiring three readings; Mr. J. Tonsic seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Mr. R. McDowall to adopt Ordinance 2022-35, a second was made by Ms. K. Miller. Vote. Unanimous ayes. Motion carried.

COMMENTS from the Public: Tracey Wagner, 3773 Prospect, asked Council again to change the time of the Council meetings back to 7:30 PM.

Council President Raddish stated he took the vote of the council at the beginning of the year, and five members said they would like the meetings at 5:30 pm, and one member said he did not care. So, at this time the meetings will stay at 5:30 PM.

Wagner indicated that the Charter states that Council meetings are to be held at 7:30 pm.

Law Director Marshal Pitchford stated that the Charter does not specifically state that Council meetings have to be held at 7:30 pm. Pitchford stated that Council can set the times of their meetings by its ordinances, resolutions, or rules.

Wagner stated that the information she obtained off the Village website showed that the meetings were supposed to start at 7:30 pm.

Mayor Rick stated he will have Law Director Marshal Pitchford look into it to see what needs to be done regarding the starting time.

Jacqueline Tycast, 3767 Prospect Street, asked if the residents will have any input on the new playground equipment?

Mayor Rick stated there is a park and recreation meeting on May 2nd that includes six residents, Councilman McDowall, and the Mayor.

Tycast stated she has had other parents in the community asking her about it and would like to know if they could put share their input with the committee on what they think?

Mayor Rick stated the other residents can email us with what kind of playground equipment they would like to see down at the park and send the information to Rachel Osborne's email that is listed on the Mogadore's webpage. Mayor Rick also stated residents are permitted to attend the Parks meeting on May 2nd and give their input.

Noris Hale, 204 S Cleveland Avenue, thanked Mayor Rick for installing the live stream so residents who can not attend can watch too.

COMMENTS from Council: Mr. Tonisc stated he watches the meetings on Facebook online and thinks it's wonderful. Mr. Raddish also thanked the Mayor as well for coming up with the live-stream idea.
