Resolution No. 2022-40

SPONSOR: STREETS COMMITTEE

A RESOLUTION AUTHORIZING THE RESURFACING OF GILCHRIST ROAD BETWEEN THE WESTERN MOGADORE CORPORATION LIMIT AND MOGADORE ROAD, INCLUDING PAVEMENT REPAIR, CASTING ADJUSTMENTS, AND PAVEMENT MARKINGS, LYING WITHIN THE VILLAGE OF MOGADORE, AND DECLARING AN EMERGENCY.

WHEREAS, on the February 2, 2022, the Village enacted legislation proposing cooperation with the Director of Transportation for resurfacing Gilchrist Road between the western Mogadore corporation limit and Mogadore Road, including pavement repair, casting adjustments, and pavement markings, lying within the Village of Mogadore, PID No. 112745; and,

WHEREAS, the Village intends to cooperate with the Director of Transportation in the above-described project by assuming and bearing one hundred percent (100%) of the entire cost of the improvement within the Village limits, less the amount of Federal- Aid funds set aside by the Director of Transportation for the financing of this improvement from funds allocated by the Federal Highway Administration, U.S. Department of Transportation; and,

WHEREAS, the share of the cost of the Village is now estimated in the amount of Three Hundred Forty-One Thousand Six Hundred Seventy-Six and 00/100 Dollars, (\$341,676.00), but said estimated amount is to be adjusted in order that the Village's ultimate share of said improvement shall correspond with said percentages of actual costs when said actual costs are determined; and,

WHEREAS, the Director of Transportation has approved said legislation proposing cooperation and has caused to be made plans and specifications and an estimate of cost and expense for improving the above-described highway and has transmitted copies of the same to this legislative authority; and

WHEREAS, the Village desires the Director of Transportation to proceed with the aforesaid highway improvement.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Portage and Summit, Ohio as follows:

SECTION 1: That the estimated sum of Three Hundred Forty-One Thousand Six Hundred Seventy-Six and 00/100 Dollars, (\$341,676.00), is hereby appropriated for the improvement described above and the Village Clerk-Treasurer is hereby authorized and directed to issue an order for said sum upon the requisition of the Director of Transportation to pay the cost and expense of said improvement. We hereby agree to assume in the first instance, the share of the cost and expense over and above the amount to be paid from Federal funds.

SECTION 2: That the Village hereby requests the Director of Transportation to proceed with the aforesaid highway improvement.

SECTION 3: That the Village enter a contract with the State, and that the Mayor, Clerk-Treasurer, and Village Engineer are hereby authorized to execute said contract, providing for the payment of the Village of Mogadore the sum of money set forth herein above for improving the described project.

SECTION 4: That the Village of Mogadore shall transmit to the Director of Transportation a fully executed copy of this Resolution.

SECTION 5: That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

SECTION 6: That it is found and determined that all formal actions of the Council relating to the adoption of this Resolution were taken in a duly noticed virtual, open meeting of this Council and that all deliberations which resulted in formal action were taken in meetings open to the public, in full compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 7: That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the Village residents, to allow for the timely commencement of work (i.e. the project) so that it can be completed in good weather, and to allow for the continued operations of the Village Service Department, Village Engineer, and other departments and shall therefore take effect and be in force from and immediately after its passage.
