RESOLUTION AND ORDER ACCEPTING THE BID AND AUTHORIZING THE MAYOR AND CLERK-TREASURER TO ENTER INTO A CONTRACT FOR SUPPLYING LABOR AND MATERIALS NECESSARY FOR THE 2022 CHIP AND SEAL REPAIRS PROJECT AND DECLARING AN EMERGENCY.

WHEREAS, Council has this day accepted the bid from Geauga Highway Company for supplying labor and materials necessary for the 2022 Chip and Seal Repairs Project, within the Village of Mogadore, all of which was previously found necessary to be done; and,

WHEREAS, said bid was the lowest responsive and responsible bid for the repairs at \$176,445.00.

NOW, THEREFORE BE IT RESOLVED, by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

<u>SECTION 1</u>: The Mayor and Clerk-Treasurer are hereby authorized and directed to enter into a contract with Geauga Highway Company in the name of the Village;

<u>SECTION 2:</u> That the Clerk-Treasurer is authorized to refund all bonds or certified checks to the successful and unsuccessful bidders upon the execution of said contract.

<u>SECTION 3:</u> That the factual findings and statements set forth in the recitals above are hereby adopted and incorporated herein.

SECTION 4: That this Council hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council which resulted in formal action were taken in meetings open to the public, in full compliance with the applicable legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 5: That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety and to allow for the timely engagement of Geauga Highway Company in order to complete the Repairs during good weather, and for continued operations of the Village Engineer's office and other departments and shall, therefore, take effect and be in force from and immediately after its passage.

## 2022 Chip and Seal Repairs Construction Bid Award Recommendation

Dear Mayor Rick,

GPD has reviewed the bids for the above referenced project.

The low bidder for the 2022 Chip and Seal Repais project is Geauga Highway Company. A review of their itemized bid does not show any front-loading or unbalanced items. Geauga Highway has included all the signed documents required with the proposal as listed in the bid package. Geauga Highway has previously performed satisfactory work in and for municipalities in the Summit County and Portage County area. The Contractor was not found to be on the State's list for Unresolved Findings for Recovery.

After completing the review process, Geauga Highway's proposal for a project total of \$176,445.00 is the lowest and best bid. The opinion of probable cost for the project was \$169,130.00. The bid is within 10 precent of the opinion of probable cost. GPD recommends entering a contract with Geauga Highway Company for the bid amount of \$176,445.00 for the 2022 Chip and Seal Repairs.

After passing legislation to award the contract, two copies of the Notice of Award and Contract should be sent to Geauga Highway for them to execute and return to the Village. The original bid packages will be returned to the Village and a bid tabulation has been provided for Village records.
