Resolution No. 2022-47

SPONSOR: UTILITIES COMMITTEE

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO SEVERAL AGREEMENT/LEASES WITH NEONET REGARDING IT/TECHNOLOGY SERVICES AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Portage and Summit, Ohio as follows:

SECTION 1: That the Mayor of the Village of Mogadore is hereby authorized and directed to promptly enter into an agreement with Northeast Ohio Network for Educational Technology, a program of the Metropolitan Regional Services Council, a regional council of governments (“NEO Net”), regarding MIBS Service Agreement, Contract Number: 50000-MIBS-2223, in a form substantially similar to the one attached as Exhibit “A” hereto.

SECTION 2: That the Mayor of the Village of Mogadore is hereby authorized and authorized and directed to promptly enter into an agreement with NEO Net regarding Service Provider VOIP Contract, Contract Number: 500007-VOIP-2223 in a form substantially similar to the one attached as Exhibit “B” hereto.

SECTION 3: That the Mayor of the Village of Mogadore is hereby authorized and directed to enter into an agreement with NEO Net regarding DTS Services Agreement, Contract Number 500007-DTS-2223 in a form substantially similar to the one attached as Exhibit “C” hereto.

SECTION 4: That the Mayor and Fiscal Officer are hereby authorized and directed to sign all necessary paperwork to effectuate the entering, execution, and implementation of said agreements.

SECTION 5: That, to the extent not already done so, the funds required for the payment of the obligations incurred are hereby appropriated for the purposes described.

SECTION 6: That this Council hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council which resulted in formal action were taken in meetings open to the public, in full compliance with the applicable legal requirements, including Section 121.22 of the Ohio Revised Code.
