Resolution No. 2022-51

SPONSOR: PARKS COMMITTEE

A RESOLUTION AUTHORIZING AND DIRECTING THE CLERK-TREASURER AND/OR VILLAGE ENGINEER TO ADVERTISE FOR BIDS FOR LABOR AND MATERIALS FOR THE LIONS PARK PICKLE BALL COURT RECONSTRUCTION PROJECT, AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Portage and Summit, Ohio as follows:

SECTION 1: It is hereby determined necessary that the Village enter into a contract for labor and materials necessary for the Lions Park Pickle Ball Court Reconstruction Project in accordance with the specifications prepared by the Village Engineer.

SECTION 2: The Clerk-Treasurer and/or the Village Engineer are hereby directed to advertise for bids for the project in accordance with plans and specifications for the project on file in the Office of the Clerk-Treasurer. A report of the responses shall be then provided to Council. The Village Engineer shall assist as necessary.

SECTION 3: All prior resolutions on this topic are rescinded and repealed.

SECTION 4: That it is found and determined that all formal actions of the Council relating to the adoption of this Resolution were taken in a duly noticed open meeting of this Council and that all deliberations which resulted in formal action were taken in meetings open to the public, in full compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5: That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and general welfare of Village residents, to allow for the timely advertisement and then submission and execution of the approved Agreement within guidelines and requirements, and to allow for the continued operations of the Village Administration and other departments and shall, therefore, take effect and be in force from and immediately after its passage.
