

COUNCIL MEETING

November 2, 2022

Council met in regular session at 5:30 p.m. with Mayor Rick presiding.

Mr. C. Yoho asked everyone to join him in a moment of reflection for their own intentions. The Pledge of Allegiance to the Flag was recited by all.

Council Meeting was held in Council Chambers. The meeting was open to the public and live-streamed on Facebook.

Motion by Mr. M. Raddish, second by Ms. K. Miller for the approval of the agenda as presented.
Vote. Unanimous ayes. Motion carried.

Motion by Mr. M. Raddish, second by Ms. B. Van Dike to adopt the minutes from the October 19, 2022, Council meeting. Vote. Unanimous ayes. Motion carried.

COMMENTS FROM THE AUDIENCE ON PENDING LEGISLATION – Carl Housley, 67 First Avenue, asked about Resolution 2022-70 agreement with the Metro Parks. Housley stated he did not know the Village had any Metro Parks in the Village.

Mayor Rick stated that we do not. The Legislation allows the Village to practice their drone over the Metro Parks.

Mr. C. Yoho presented Resolution 2022-70 sponsored by Safety Committee as follows:

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE SUMMIT COUNTY METRO PARKS WAIVING ITS RESTRICTIONS REGARDING RULES 10.5 AND 10.6 SO AS TO ALLOW THE VILLAGE OF MOGADORE TO CONDUCT FLIGHT OPERATIONS ABOVE PARK PROPERTY; AND DECLARING AN EMERGENCY.

Mr. C. Yoho made a motion to suspend the rules requiring three readings; Ms. K. Miller seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Mr. W. Bauer to adopt Resolution 2022-70, a second was made by Ms. K. Miller. Vote. Unanimous ayes. Motion carried.

Mr. C. Yoho presented Resolution 2022-71 sponsored by Safety Committee as follows:

A RESOLUTION AUTHORIZING THE MAYOR AND/OR POLICE CHIEF TO ENTER INTO INFORMATION EXCHANGE AGREEMENTS REGARDING THE SHARING OF CRIMINAL JUSTICE INFORMATION (CJI) FOR THE PURPOSES OF COMPLIANCE WITH REGULATIONS SURROUNDING THE LAW ENFORCEMENT AUTOMATED DATA SYSTEM (LEADS); AND DECLARING AN EMERGENCY.

Mr. C. Yoho made a motion to suspend the rules requiring three readings; Ms. W. Bauer seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Mr. C. Yoho to adopt Resolution 2022-71, a second was made by Mr. W. Bauer. Vote. Unanimous ayes. Motion carried.

Mr. C. Yoho presented Resolution 2022-72 sponsored by Safety Committee as follows:

A RESOLUTION AUTHORIZING THE MAYOR AND/OR FIRE CHIEF TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH OTHER COMMUNITIES IN ORDER TO SUBMIT A JOINT APPLICATION FOR A FEMA GRANT AND TO PURCHASE OF RADIOS; AND DECLARING AN EMERGENCY.

Mr. C. Yoho made a motion to suspend the rules requiring three readings; Mr. J. Tonsic seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Mr. C. Yoho to adopt Resolution 2022-72, a second was made by Ms. B. Van Dike. Vote. Unanimous ayes. Motion carried.

COMMENTS from the Public: Carl Housley, 67 First Avenue, asked about legislation 2022-66 Transfer from the general fund to the safer fund.

Scott Varney stated all money is deposited into the general fund first and then it will go into the Safer fund for the Fire Department.

Housley asked if the Fire Department has hired anyone as full-time yet.

Mayor Rick stated he has not heard from the Fire Chief that anyone has been hired at this time.

Michele Housley, 67 First Avenue, thanked Mayor Rick for putting up the speed sign on her street. Housley stated it has helped slow down some people from speeding but mostly has cut back the amount of traffic down their road.

COMMENTS from Council: Mr. McDowall reminded everyone to vote next week.

COMMENTS from the Law Director: Councilmen Raddish and Bauer questioned the progress on the Landenberger property. They asked what will be done in the future if the same problem arises.

Mr. Pitchford indicated he would get back to them at a later meeting on the issue.

COMMENTS from the Mayor: Mayor Rick reminded everyone of leaf pickup and wished the High School Girls Cross Country team good luck at State.
