COUNCIL MEETING

February 1, 2023

Council met in regular session at 5:30 p.m. with Mayor Rick presiding.

Mr. M. Raddish asked everyone to join him in a moment of reflection for their own intentions. The Pledge of Allegiance to the Flag was recited by all.

Council Meeting was held in Council Chambers. The meeting was open to the public and live-streamed on Facebook.

Roll Call: Council Members Present: Mr. R. McDowall, Ms. B. Van Dike, Mr. M. Raddish, Mr. J. Tonsic, and Mr. W. Bauer. Not Present: Mr. C. Yoho and Ms. K. Miller.

Others Present: Mayor Rick, Council Clerk Rachel Osborne, Clerk-Treasurer Scott Varney, and Law Director Jason Dodson.

Motion by Mr. M. Raddish, second by Mr. R. McDowall for the approval of the agenda as presented. Vote. Unanimous ayes. Motion carried.

Motion by Mr. M. Raddish, second by Mr. W. Bauer to adopt the minutes from January 18, 2023, Council meeting. Vote. Unanimous ayes. Motion carried.

<u>COMMENTS FROM THE AUDIENCE ON PENDING LEGISLATION</u> – No Comments.

COMMITTEE REPORTS -

UTILITIES – Mr. Bauer reported he had no report.

SAFETY – Mr. Yoho was not present.

PARKS – Mr. McDowall reported he has two pieces of legislation to read.

PLANNING AND ZONING – Ms. Miller was not present.

FINANCE/AUDIT - Ms. Van Dike reported she has three pieces of legislation to read.

STREETS – Mr. Tonsic reported he has one piece of legislation to read.

Council President Mr. Raddish announced he has one piece of legislation to read and the next Work Session will be held Wednesday, February 22, 2023, at 5:30 p.m. with all committees reporting.

OLD BUSINESS - None.

NEW BUSINESS -

Mr. J. Tonsic presented Resolution 2023-12 sponsored by Streets Committee as follows:

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT TO PURCHASE A JOHNSTON VT 650 STREET SWEEPER FROM BROWN EQUIPMENT COMPANY ON AN EMERGENCY BASIS FOR USE BY THE STREET DEPARTMENT, AND DECLARING AN EMERGENCY.

Mr. J. Tonsic made a motion to suspend the rules requiring three readings; Ms. B. Van Dike seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Mr. J. Tonsic to adopt Resolution 2023-12, a second was made by Mr. W. Bauer.

Mayor Rick asked Dodson to let the council know why this can be done as an emergency.

Dodson stated the Charter requires any purchase over \$25,000, one-half the statutory limit, has to be bid. However, the Charter also allows the approval of five or more council members to bypass that provision in an event of an emergency. After speaking with the Mayor and the Street Department the concern is with some requirements under EPA guidelines to utilize the Street sweeper as a pollution control measure.

Mayor Rick reminded the council this is a used street sweeper.

Bauer asked if there will be a warranty.

Mayor Rick stated he will check with Gary Maag and get back to him.

Vote. Unanimous ayes. Motion carried.

Mr. R. McDowall presented Resolution 2023-13 sponsored by Parks Committee as follows:

A RESOLUTION AUTHORIZING THE VILLAGE OF MOGADORE TO APPLY FOR AND ACCEPT A GRANT FROM THE OHIO DEPARTMENT OF NATURAL RESOURCES RECREATIONAL TRAILS PROGRAM TO SUPPORT THE CONSTRUCTION OF A NEW TRAIL IN LIONS PARK, AND DECLARING AN EMERGENCY.

Mr. R. McDowall made a motion to suspend the rules requiring three readings; Ms. B. Van Dike seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Mr. R. McDowall to adopt Resolution 2023-13, a second was made by Mr. J. Tonsic.

Mayor Rick stated the Village has received the grant for the walking trail of \$34,000 and will be applying for a second grant for additional money to go toward the building cost. Mayor Rick stated either way the Village is still building the trail regardless of if approved for the second grant.

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE AND DELIVER ALL DOCUMENTS NECESSARY TO PARTICIPATE IN LITIGATION SETTLEMENTS WITH OPIOID MANUFACTURERS, TEVA AND ALLERGAN, AND PHARMACIES, CVS, WALGREENS AND WALMART, AND DECLARING AN EMERGENCY.

Dodson announced there will be an additional settlement coming to the Village but doesn't expect it to be a large sum of money.

Bauer asked about the use of funding, and does the council get to decide how that money will be spent.

Dodson stated the council can spend the money on police, fire, or school programs that has to do with the OPIOID epidemic.
