SPONSOR: STREETS COMMITTEE

A RESOLUTION AWARDING THE BID FOR THE 2023 CHIP AND SEAL STREET REPAIRS PROJECT TO GEAUGA HIGHWAY COMPANY, AUTHORIZING THE MAYOR AND CLERK-TREASURER TO ENTER INTO A CONSTRUCTION CONTRACT WITH GEAUGA HIGHWAY COMPANY TO PROVIDE LABOR AND MATERIALS FOR SAID PROJECT, AND DECLARING AN EMERGENCY.

WHEREAS, Section 14.03 of the Village's Charter provides that all purchases exceeding one-half (1/2) of the statutory threshold of \$50,000.00 shall be undertaken by advertising for and accepting sealed bids, except when five (5) members of this Council determine the purchase should proceed without such sealed bids due to an emergency; and

WHEREAS, in accordance with Section 14.03 of the Village's Charter, this Council previously adopted Resolution No. 2022.78 to authorize and direct the Clerk-Treasurer to advertise for bids for the 2023 Chip and Seal Street Repairs Project; and

WHEREAS, thereafter, the Clerk-Treasurer advertised for bids for the 2023 Chip and Seal Street Repairs Project and the received bids for the same; and

WHEREAS, upon review of the bids, the Village Engineer recommended that this Council award the bid for the 2023 Chip and Seal Street Repairs Project to Geauga Highway Company as the lowest responsive and responsible bidder in the amount of \$123,967.00; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the Village of Mogadore to award the bid for the 2023 Chip and Seal Street Repairs Project to Geauga Highway Company and to authorize the Mayor and Clerk-Treasurer to enter into a construction contract for Geauga Highway Company to provide labor and materials for said project.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

SECTION 1: This Council hereby awards the bid for the 2023 Chip and Seal Street Repairs Project to Geauga Highway Company as the lowest responsive and responsible bidder in the amount of \$123,967.00.

SECTION 2: The Mayor and Clerk-Treasurer are hereby authorized and directed to enter into a construction contract with Geauga Highway Company to provide labor and materials for the 2023 Chip and Seal Street Repairs Project.

SECTION 3: The Clerk-Treasurer is hereby authorized and directed to refund all bonds or certified checks to the successful and unsuccessful bidders upon the execution of the aforementioned construction contract.

SPONSOR: FINANCE COMMITTEE

A RESOLUTION ESTABLISHING RATES OF PAY FOR THE PART-TIME PARKS AND CEMETERY EMPLOYEES OF THE VILLAGE, AND DECLARING AN EMERGENCY.

WHEREAS, this Council establishes the rates of pay for the various part-time employees of the Village, including the Part-Time Parks Maintenance Supervisor, Part-Time Parks Maintenance Assistant Supervisor, Part-Time Parks Maintenance Workers, Part-Time Parks Recreation Supervisor, Part-Time Parks Recreation Workers, and Part-Time Cemetery Maintenance Workers (collectively the "Part-Time Parks and Cemetery Employees"); and

WHEREAS, the Mayor has recommended to this Council that the rates of pay for the Part-Time Parks and Cemetery Employees be established as not to exceed Fifteen Dollars (\$15.00) per hour, payable bi-weekly, and that the precise amount of pay for the individuals filling those positions be further established by the Mayor; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the Village of Mogadore to establish the rates of pay for the Part-Time Parks and Cemetery Employees as set forth above.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

SECTION 1: The Part-Time Parks Maintenance Supervisor, Part-Time Parks Maintenance Assistant Supervisor, Part-Time Parks Maintenance Workers, Part-Time Parks Recreation Supervisor, Part-Time Parks Recreation Assistant Supervisor, Part-Time Parks Recreation Workers, and Part-Time Cemetery Maintenance Workers shall receive compensation for their services at a rate between the Ohio minimum wage and an amount not to exceed Fifteen Dollars (\$15.00) per hour, payable bi-weekly. The precise amount paid to the individuals filling these positions, within the range set forth in this Section, shall be further established by the Mayor.

SECTION 2: Any prior Resolutions or Ordinances adopted by this Council, or any provisions thereof, that are in conflict with Section 1 of this Resolution are hereby rescinded and repealed in their entirety.

SECTION 3: This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in this formal action were in meetings open to the public, in compliance with all legal requirements.

SECTION 4: This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the residents of the Village of Mogadore and for the purpose of immediately and appropriately compensating the Part-Time Parks and Cemetery Employees prior to commencement of hiring many of the individuals for those
