WHEREAS, Section 152.133 of the Village's Codified Ordinances provides this Council the authority to modify the number, shape or area of the districts established by the Codified Ordinances and set forth on the Village's zoning map, including amending said zoning map, provided that the Village complies with the procedural requirements contained therein; and

WHEREAS, the owners of the real property located at 176 North Cleveland Avenue, Mogadore, OH 44260, consisting of 1.016 acres and identified in the Summit County Records as Parcel No. 5500181 (the "Property") previously filed an application with the Clerk-Treasurer to rezone the Property from an R-1 zoning district designation to an R-2 zoning district designation; and

WHEREAS, following proper notice, this Council and the Village's Planning Commission held a joint hearing on the application for the rezoning of the Property from an R-1 zoning district designation to an R-2 zoning district designation on June 12, 2023, pursuant to Section 152.133 of the Village's Codified Ordinances; and

WHEREAS, on June 26, 2023, the Village's Planning Commission voted unanimously to recommend the rezoning of the Property from an R-1 zoning district designation to an R-2 zoning district designation; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the Village to rezone the Property from an R-1 zoning district designation to an R-2 zoning district as set forth herein, and to amend the Village's zoning map accordingly.

NOW, THEREFORE BE IT ORDAINED, by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

<u>SECTION 1</u>: Pursuant to Section 152.133 of the Village's Codified Ordinances, this Council hereby rezones the Property from an R-1 zoning district designation to an R-2 zoning district.

WHEREAS, Chapter 93 of the Village of Mogadore Codified Ordinances sets forth the nuisance code of the Village; and

WHEREAS, the Mayor has recommended that this Council adopt Section 93.56 of the Codified Ordinances of the Village, entitled "Exterior Lighting," as set forth on Exhibit A, attached hereto and incorporated herein by reference, which will regulate the use of exterior lighting in the Village to prevent the same from becoming a nuisance; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the Village to adopt Section 93.56 for the reasons set forth above.

NOW, THEREFORE BE IT ORDAINED, by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

<u>SECTION 1</u>: This Council hereby adopts Section 93.56 of the Codified Ordinances of the Village, entitled "Exterior Lighting," as set forth on Exhibit A, attached hereto and incorporated herein by reference.

SECTION 2: This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in this formal action were in meetings open to the public, in compliance with all legal requirements.

SECTION 3: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the residents of the Village of Mogadore and for the purpose of immediately regulating the use of exterior lighting that may constitute a nuisance in the Village, and, provided this Ordinance receives the affirmative vote of at least five (5) members elected or appointed to this Council, it shall take effect and be in force upon its passage by Council and approval by the Mayor, otherwise it shall take effect and be in force at the earliest period allowed by law.

EXHIBIT A

93.56 EXTERIOR LIGHTING

- (A) No owner or occupant of property shall place or permit the placement of exterior lighting upon any building or property owned or occupied by him or her unless such lighting is designed and placed in such a manner and is of such illumination as to confine illumination to the property upon which it is placed and prevent unreasonable shining, lighting, glare or reflection upon neighboring residential premises or upon public streets.
- (B) Whoever violates any provision of this chapter is guilty of a minor misdemeanor. Each day the violation persists shall be deemed a separate violation.

WHEREAS, Chapter 152 of the Village of Mogadore Codified Ordinances serves as the zoning code of the Village; and

WHEREAS, the Mayor has recommended that this Council adopt Section 152.037 of the Codified Ordinances of the Village, entitled "Exterior Lighting," as set forth on Exhibit A, attached hereto and incorporated herein by reference, which will provide zoning regulations and restrictions on the use of exterior lighting in the Village; and

WHEREAS, the Mayor has also recommended that this Council amend Section 152.113 of the Codified Ordinances of the Village, entitled "Specific Regulations Pertaining to Conditionally Permitted Uses," as set forth on Exhibit A, attached hereto and incorporated herein by reference, to require that all conditional uses comply with Section 152.037; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the Village to adopt Section 152.037 and amend Section 152.113 for the reasons set forth above.

NOW, THEREFORE BE IT ORDAINED, by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

SECTION 1: This Council hereby adopts Section 152.037 of the Codified Ordinances of the Village, entitled "Exterior Lighting," as set forth on Exhibit A, attached hereto and incorporated herein by reference.

SECTION 2: This Council hereby amends Section 152.113 of the Codified Ordinances of the Village, entitled "Specific Regulations Pertaining to Conditionally Permitted Uses," as set forth on Exhibit A, attached hereto and incorporated herein by reference.

EXHIBIT A

152.037 EXTERIOR LIGHTING.

In addition to Section 150.218 concerning the lighting and illumination of signs and billboards, Section 152.024 concerning off-street parking, and Section 152.047 concerning car lots in C-1 Commercial Districts, all external lighting in all districts shall comply with the following:

- (a) All external lighting used to light the general area of a specific portion or property shall be shielded to reduce glare and shall be so arranged as to reflect lights away from, and shield glare from, and not shine directly upon, all adjacent residential districts, adjacent residences, and adjacent streets and public right of ways.
- (b) All external lighting, other than lighting for the illumination of buildings or lighting and illumination of signs and billboards, shall be directed toward and confined to the ground areas of lawns or parking lots on the property where the lighting is located.
- (c) All lighting used for the external illumination of buildings, so as to feature such buildings, shall be placed and shielded so as not to interfere with the vision of persons on adjacent property or adjacent streets and public right of ways.
- (d) All lighting or illumination of signs and billboards shall comply with Section 150.218 of these Codified Ordinances.

152.113 SPECIFIC REGULATIONS PERTAINING TO CONDITIONALLY PERMISSIBLE USES.

(E) No lighting shall constitute a nuisance and shall in no way impair safe movement of traffic on any street or highway; no lighting shall shine directly on adjacent properties. All lighting shall comply with Section 152.037 of these Codified Ordinances.

WHEREAS, the Summit Area Regional Council of Governments has been created by the County of Summit and the Cities of Cuyahoga Falls, Fairlawn, Stow and Tallmadge ("SARCOG") for the operation of a joint public safety dispatch facility at 630 North Ave., Tallmadge, OH 44278 known as the Summit Emergency Communications Center ("SECC"); and

WHEREAS, it is anticipated that the Village will contract with SARCOG to perform public safety dispatching on behalf of the Village; and

WHEREAS, Ohio Administrative Code Section 4501:2-10-03(A)(2) requires the any joint dispatching facility enter into a management control agreement with each criminal justice agency it serves to ensure compliance by that joint dispatching facility with Law Enforcement Automated Data System ("LEADS") rules; and

WHEREAS, for the reasons set forth above, the Mayor has recommended that the Village enter into a management control agreement with SARCOG, on behalf of the SECC, in the form attached hereto as Exhibit A, attached hereto and incorporated herein, together with any revisions thereto approved by the Village Law Director that are not materially adverse to the Village; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the Village of Mogadore to authorize the Mayor to execute the management control agreement with SARCOG on behalf of the SECC.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

SECTION 1: The Mayor is hereby authorized execute the management control agreement with SARCOG, on behalf of the SECC, in the form attached hereto as Exhibit A, attached hereto and incorporated herein, together with any revisions thereto approved by the Village Law Director that are not materially adverse to the Village.

EXHIBIT A

Management Control Agreement between the Village of Mogadore on behalf of the Mogadore Police Department and the Summit Area Regional Council of Governments on behalf of the Summit Emergency Communications Center

This Management Control Agreement is entered into by and between the Summit Area Regional Council of Governments, on behalf of the Summit Emergency Communications Center ("SECC"), having its principal place of business located at 630 North Ave. Tallmadge, Ohio 44278 and the Village of Mogadore on behalf of the Mogadore Police Department ("AGENCY"), having its principal place of business located at 1235 S. Cleveland Ave., Mogadore, OH 44260, collectively known as "Parties".

WHEREAS, Ohio Administrative Code (OAC) 4501:2-10-03(A)(2) requires that a criminal justice agency has a written agreement with a governmental division which operates the data equipment used by agencies to access Law Enforcement Automated Data System (LEADS)/National Crime Information Center (NCIC) to assure the criminal justice agency has management control. This includes regional dispatch centers as a cooperative effort by political subdivisions in a particular area for the purpose of providing consolidated and computer-assisted dispatch for public safety purposes; that is, police, fire, and rescue services; and

WHEREAS, AGENCY, a criminal justice agency as designated by the State of Ohio LEADS, is a Terminal Agency that qualifies for their originating agency identifier (ORI OHXXXXXXX); and

WHEREAS, SECC, a cooperative dispatching agency designated under OAC 4501:2-10-03(A)(5), is a Terminal Agency that qualifies for an originating agency identifier (ORI XXXXXXX); and

WHEREAS, the purpose of this agreement is to establish and enforce Security Control of the access and use of the CJI, LEADS and associated ODPS, FBI and other systems in a location where access to and/or use of that system is accomplished by a CJA with the assistance of NCJA.

DEFINITIONS

- <u>a. Law Enforcement Automated Data System (LEADS)</u> A computerized network administered by the Ohio State Highway Patrol, which provides computerized data and communications for criminal justice agencies within the state of Ohio. (OAC 4501:210-01(W))
- <u>b.</u> <u>National Crime Information Center (NCIC)</u> The nationwide computerized filing system established for criminal justice agencies at the local, state, and federal levels and is managed by the Federal Bureau of Investigation (FBI). (OAC 4501:2-10-01(11))
- c. Criminal Justice Functions hardware, software, network, dispatching functions
- d. Criminal Justice Information (CJI) the abstract term used to refer to all of the LEADS provided data necessary for law enforcement agencies to perform their mission and enforce the laws, including but not limited to: biometric, identity history, person (includes driver's license photo, SSN, etc.), organization, property (when accompanied by any personally identifiable information), and case/incident history data. The following type of data are exempt from the protection levels required for CJI: transaction control type numbers (e.g. ORI, NIC, FNU, etc.) when not accompanied by information that reveals CJI or PII and BMV driving records. (OAC 4501:2-10-01(M))
- e. Security Controls Activities including, but not limited to, the supervision of applicable equipment system design programming and operating procedures associated with the development implementation and operation of any computerized message switching or database systems utilized by the served law enforcement agency for agencies. Computer

sites must have adequate physical security to protect against any unauthorized viewing or access to computer terminals access devices or stored slash printed data.

II. SCOPE OF MANAGEMENT CONTROL

- a. This agreement is prepared to comply with the LEADS requirements for SECC personnel who may function under LEADS administrative roles during the course of business.
- b. The SECC agrees to sign and execute a LEADS Terminal Agency Agreement and, by doing so, agrees to abide by all the rules and regulations required by that agreement.
- c. Administrative Control over SECC assets, personnel and infrastructure will remain with SECC.
- d. Unauthorized personnel will be restricted access to SECC property and infrastructure systems.
- e. SECC agrees to utilize interconnected state and national repositories (LEADS, NCIC, NLETS) and information contained therein, in accordance with LEADS and criminal justice agency standards.
- f. SECC agrees to develop local policy and procedure to meet the requirements if the LEADS Terminal Agency Agreement.

III. TERM AND TERMINATION

- a. This Agreement shall commence on the first day the Agency's dispatch center transfers to SECC and shall continue in full force and effect until either party has a change of Agency Administrator.
- b. This Agreement may be terminated for any reason, with thirty (30) days written notice to the other party.

IV. AMENDMENT

a. Amendments to this agreement must be in writing and require updated signatures.

V. LEADS Owned Equipment/ Connected Agency Owned Equipment (OAC 4501:2-10-10)

- a. SECC personnel, if called upon to assist in maintaining LEADS equipment shall notify LEADS of any malfunctions of its equipment, if the SECC personnel have not already done so.
- b. SECC owned equipment used to access LEADS, shall be supported by repair service as required by the LEADS security policy as a minimum.
- c. LEADS owned equipment shall not be changed, modified, turned off, unplugged, or rendered inoperable in any manner except in the case of equipment malfunction preventing operation or if directed by LEADS personnel or equipment contract repair personnel.
- d. All repairs on LEADS owned and serviced equipment shall be initiated through LEADS.
- e. LEADS owned equipment shall not be changed in any manner or moved from the installed position without permission of the CMS System Officer (CSO). All written requests to change or move LEADS owned equipment shall be forwarded through the SECC Terminal Agency Coordinator (TAC).
- f. SECC shall provide written notice to LEADS of any relocation of LEADS owned equipment accessing LEADS or any change request shall be submitted in writing at least forty-five days in advance of the move. Prior to relocating equipment, a site inspection may be conducted, and location approved by LEADS staff.

- g. Modifications or additions of any SECC owned equipment connected to LEADS shall be approved in writing by LEADS.
- h. No remote access is permitted to LEADS except as approved by LEADS. Remote access to agency owned equipment is prohibited while the equipment is on-line with LEADS, except as approved and monitored by LEADS control.
- i. SECC owned software is not permitted to be installed in LEADS owned equipment. SECC equipment and/or software believed to be degrading LEADS service shall be disconnected until the problem is resolved.
- j. LEADS owned equipment/software or equipment/software connected to LEADS shall not be interconnected to other systems or networks without written authorization from the CSO.
- k. LEADS owned equipment/software shall not be used for personal benefit.

We, the undersigned Parties, agree to the above purpose, principles, and standards of the

1. All equipment/software use will be monitored continually by LEADS control and randomly by LEADS staff or their representatives. Any misuse shall be cause for administrative sanction and/or criminal prosecution.
