A RESOLUTION AUTHORIZING THE MAYOR TO ACCEPT A 2022 FEMA ASSISTANCE TO FIREFIGHTERS GRANT, AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to Resolution 2022-72, this Council authorized the Mayor to enter into a Memorandum of Understanding with other communities to apply for a 2022 FEMA Assistance to Firefighters Grant, and to purchase radios with funds from said grant; and

WHEREAS, the Mayor entered into the aforementioned Memorandum of Understanding, the aforementioned grant was applied for, and the aforementioned grant has been awarded to the Village; and

WHEREAS, the Mayor has requested that this Council authorize the Mayor to accept the 2022 FEMA Assistance to Firefighters Grant; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the Village to authorize the Mayor to accept the 2022 FEMA Assistance to Firefighters Grant.

NOW, THEREFORE BE IT RESOLVED, by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

SECTION 1: This Council hereby authorizes the Mayor to accept the 2022 FEMA Assistance to Firefighters Grant. In accordance with said authorization, the Mayor, Clerk-Treasurer and Fire Chief are hereby authorized and directed to execute all agreements and other documents necessary to accept said grant funds.

SECTION 2: This Council reaffirms the authorization provided in Resolution 2022-72 for the Mayor and/or Fire Chief to purchase the necessary radios using the aforementioned grant funds in a collective amount not to exceed \$25,000.00, and each are authorized to execute any agreements and other documents necessary to effectuate the same.

SECTION 3: This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in this formal action were in meetings open to the public, in compliance with all legal requirements.

SECTION 4: This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the residents of the Village of Mogadore and for the purpose of immediately accepting the grant so that radios may be purchased and the Village maintains a functional public safety communication network, and, provided this Resolution receives the affirmative vote of at least five (5) members elected or appointed to this Council, it shall take effect and be in force upon its passage by Council and approval by the Mayor, otherwise it shall take effect and be in force at the earliest period allowed by law.
