RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION OF SUMMIT COUNTY, OHIO, AUTHORIZING THE NECESSARY TAX LEVIES, CERTIFYING THEM TO THE SUMMIT COUNTY FISCAL OFFICER AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to Section 5705.34 of the Ohio Revised Code, the Budget Commission of Summit County, Ohio has certified its action thereon to this Council together with an estimate by the County Fiscal Officer of the rate of each tax necessary to be levied by this Council in fiscal year 2024, and what part thereof is without, and what part is within the ten-mill tax limitation; and

WHEREAS, pursuant to Section 5705.34 of the Ohio Revised Code, it is necessary and in the best interest of the Village to accept the amounts and rates as determined by the Budget Commission of Summit County, authorize the necessary tax levies and to certify the same to the Summit County Fiscal Officer.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

SECTION 1: The amounts and rates to be levied upon the tax duplicate of the Village in fiscal year 2024, as determined by the Budget Commission of Summit County, Ohio in its certification, be and the same are hereby accepted.
