A RESOLUTION AUTHORIZING THE MAYOR TO ACCEPT A GRANT AWARD IN THE AMOUNT OF \$42,675.00 FROM THE SUMMIT COUNTY SHERIFF'S OFFICE, AND DECLARING AN EMERGENCY.

WHEREAS, the Village has been awarded a grant in the amount of \$42,675.00 from the Summit County Sheriff's Office for the purchase of a 2024 Ford F150 Responder Police Vehicle for official use within the Village; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the Village to authorize the Mayor to accept the grant in the amount of \$42,675.00 from the Summit County Sheriff's Office.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

SECTION 1: The Mayor is hereby authorized to accept the grant in the amount of \$55,000.00 from the Summit County Sheriff's Office for the purchase of a 2024 Ford F150 Responder Police Vehicle for official use within the Village. In accordance with said authorization, the Mayor is hereby authorized and directed to execute the grant agreement to accept and receive said grant funds.

SECTION 2: The Mayor, Clerk-Treasurer and Police Chief are hereby authorized to sign all other agreements and documents and take all other actions necessary to accept and receive the aforementioned grant.

SECTION 3: This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in this formal action were in meetings open to the public, in compliance with all legal requirements.

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH MONTROSE FORD TO PURCHASE A 2024 FORD F150 RESPONDER POLICE VEHICLE AT STATE-TERM CONTRACT PRICING WHICH WILL NOT EXCEED \$55,000.00, AND DECLARING AN EMERGENCY.

WHEREAS, Section 14.03 of the Village's Charter provides that all purchases exceeding one-half (1/2) of the statutory threshold of \$75,000.00 shall be undertaken by advertising for and accepting sealed bids; and

WHEREAS, Section 125.04 of the Ohio Revised Code provides an exception to the Village's requirement for competitive bidding for the purchase of goods and services through the Village's participation in a pricing procured by the State of Ohio Department of Administrative Services ("State-Term Contract"); and

WHEREAS, the Mayor and Chief of Police desire to place an order with Montrose Ford, at State-Term Contract pricing, for a 2024 Ford F150 Responder Police Vehicle in an amount not to exceed \$55,000.00; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the Village to authorize the Mayor to enter into an agreement to purchase a 2024 Ford F150 Responder Police Vehicle in an amount not to exceed \$55,000.00 pursuant to State-Term Contract pricing.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

SECTION 1: The Mayor is hereby authorized to enter into an agreement to purchase a 2024 Ford F150 Responder Police Vehicle in an amount not to exceed \$55,000.00 pursuant to State-Term Contract pricing.

SECTION 2: The Mayor and all other Village officials are authorized and directed to sign and/or enter into any instruments of conveyance or other documents necessary to effectuate the provisions of this Resolution. Additionally, the Mayor and Police Chief are authorized to enter into any purchase orders of less than \$25,000.00 necessary to equip the 2024 Ford F150 Responder Police Vehicle.
