A RESOLUTION CONFIRMING THE APPOINTMENTS OF CHRISTINA DEIBEL AND JIM MOORE TO THE VILLAGE'S PLANNING AND ZONING COMMISSION FOR A TERM COMMENCING ON JANUARY 1, 2025 AND ENDING ON DECEMBER 31, 2027, AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

SECTION 1: This Council hereby confirms the appointments of Christina Deibel and Jim Moore to the Village's Planning and Zoning Commission for terms commencing on January 1, 2025 and ending on December 31, 2027.

SECTION 2: The Village of Mogadore finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in this formal action were in meetings open to the public, in compliance with all legal requirements.

SECTION 3: This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the residents of the Village of Mogadore and for the purpose of immediately confirming the aforementioned appointments prior to the expiration of the current terms, and, provided this Resolution receives the affirmative vote of at least five (5) members elected or appointed to this Council, it shall take effect and be in force upon its passage by Council and approval by the Mayor, otherwise it shall take effect and be in force at the earliest period allowed by law.
